

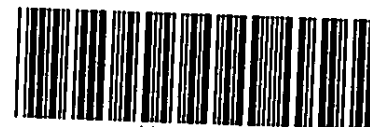



On a poll every member who is present in person or by proxy shall have one vote for every share of which he is the holder.</p> <p>Subject to the provisions of the Companies Acts, the company may by ordinary resolution from time to time declare dividends in accordance with the respective rights of the members, but no dividend shall exceed the amount recommended by the board.</p>
