#### Introduction

- This report is the final progress report on the Administration of the Company made pursuant to Rule 2 47 of the Insolvency Rules 1986 ("the Rules")
- 1 2 It is considered that the EC Regulation on insolvency proceedings will apply and that these proceedings will be main proceedings as defined in Article 3 of the EC Regulation

#### Administrator's Proposals

- 2 1 The modified proposals of the Joint Administrators are
  - 1) That the Company proceeds into Creditors Voluntary Liquidation on or before 21 June 2010
  - 11) That Gareth Rusling and John Russell of the P & A Partnership, 93 Queen Street, Sheffield. S1 1WF be appointed as Joint Liquidators
  - That the Administrator's remuneration be limited to time properly spent in dealing with the affairs of the Company up to the date of discharge on or before 21 June 2010

#### Administrator's Actions

- In the last report to creditors it was noted that the Company had a significant debtor ledger totalling £378.352 85
- Given the nature of the industry specialist construction solicitors were instructed to review the debtor ledger and assist with the ongoing collection
- An extensive review of the Company's books and records was conducted with the collection's agency to assess the nature of the records held and to gain a better understanding of any known and existing disputes
- 3 4 Appropriate records were passed to the collection's agency to assist with the initial enquiries
- Upon appointment it had also been noted that the Company had an ongoing dispute with a former director and existing shareholder
- A meeting was held with the current directors to gain a full history and better understanding of the dispute.
- Following this meeting correspondence has been entered into with the former director's solicitor to establish if there are any further matters that require investigation
- In order to assist with this line of enquiry correspondence was also entered into with the Company's former accountant who has been instructed to establish the extent of any loss caused by the dispute

#### Remuneration

- As per the accepted proposals, the Joint Administrators' remuneration is to be calculated on a time cost basis. To date £19.395.16 has been drawn from the Administration in relation to this.
