In accordance with the provisions of Section 94 of the Insolvency Act 1986, I present, for your information, my final progress report on the liquidations for the period 24 September 2014 to 16 September 2015

#### **Statutory Information**

I, Malcolm Cohen, of BDO LLP, 55 Baker Street, London, W1U 7EU was appointed as Liquidator of the Companies on 24 September 2014

The Companies' respective registered numbers are listed above, and their former company names and trading addresses are detailed in the attached Schedule A

The former registered office for the Companies was 6<sup>th</sup> Floor, 77 Gracechurch Street, London, EC3V 0AS, and this was changed to 55 Baker Street, London, W1U 7EU following my appointment

The Companies do not have any other trading styles

#### **Receipts and Payments**

I enclose a receipts and payments account for each of the Companies. The contents are self-explanatory but I would confirm that following my appointment steps were taken to open bank accounts for each of the Companies, and requests were made for the funds held on the Companies' existing bank accounts at Lloyds Bank plc to be transferred to the liquidation accounts.

Some delays were experienced and the bulk of the funds were not received until early December 2014. I was advised that all funds had been transferred but it transpired that an account for each of the Companies had been overlooked, and I received the final funds from Lloyds in mid February 2015

The tax refund received by DSBH is in respect of a s.455 claim for the period ended 30 September 2011

BDO LLP is authorised and regulated by the Financial Conduct Authority to conduct investment business.





Distributions of the remaining funds held were made to the Companies' respective members prior to the final meetings of members being held. With the approval of the Companies' ultimate shareholder, Alderande S A S, to expedite matters and to minimise bank charges, payments were made direct to Alderande S A S.

# Other Assets

The declarations of solvency sworn by the Companies' directors included estimated summaries of assets and liabilities as at 31 August 2014 These detailed the cash balances outlined above, and also the assets listed below

#### <u>Investments</u>

DSBH and CTSB are wholly owned by IDFG DSB is owned by IDFG (33 39%) and CTSB (66.61%). DSB owns 100% of the shares in Investissement Hotelier Saint Barth Plage des Flamands SAS ("IHSBPF"), a company registered in Saint Barthelemy

Prior to the conclusion of the liquidations, distributions in specie of the Companies' respective investments were made to their respective members, which resulted in IHSBPF being wholly owned by IDFG's shareholder, Alderande S A S

The order of distributions was as follows

- CTSB
- DSB
- DSBH
- IDFG

# **VAT** Debtor

All of the Companies with the exception of CTSB detailed small VAT debtors. It has transpired that the Companies were de-registered for VAT on 5 July 2014 and all amounts had been recovered prior to my appointment.

#### S 455 Tax Refund

DSBH showed a debtor balance of €17,983 in respect of a s 455 tax refund. The majority of this sum has been recovered as detailed above. However the sum of £1,733 25 remains outstanding in relation to a claim for the final pre-liquidation period. Refunds of this type are recoverable nine months after the end of the accounting period to which the claim relates, and hence the refund should be made imminently by HM Revenue & Customs ("HMRC")

In light of the sum involved, and to prevent the liquidations lasting more than one year resulting in the necessity of preparing annual progress reports, with the agreement of Alderande S A.S , the final meetings were convened to close the liquidations. The residual s.455 debtor has been distributed in specie instead



#### **HMRC**

#### Corporation Tax

Corporation tax returns for the pre-liquidation periods were submitted to HMRC by the Companies' tax agents in mid November 2014. These all detailed nil liabilities.

# VAT

As outlined above, it transpired that the Companies' VAT group had been de-registered on 5 July 2014 but a final return was required. This was submitted in October 2014

#### PAYE

Only DSBH operated a PAYE scheme and the final returns were submitted in July 2015.

Further to the above, I have corresponded with HMRC and can confirm that I have received formal tax clearances from the Inspector at the Corporation Tax office and the Enforcement and Insolvency Service unit with confirmation that no further returns are required and that there are no objections to the liquidations being concluded

## Liquidator's Remuneration

Pursuant to the insolvency Rules 1986, the Liquidator is obliged to fix his remuneration in accordance with Rule 4 148A(2) of the insolvency Rules 1986. This permits remuneration to be fixed either

- (1) as a percentage of the assets realised and distributed; and/or
- (2) by reference to the time the Liquidator and the staff have spent attending to matters in the liquidation, and/or
- (3) as a set amount, and/or
- (4) as a combination of the above

My remuneration was approved on a time costs basis on the date of my appointment. I enclose a summary of the time costs incurred by myself and my staff for each of the Companies which detail a total of 91.7 hours of time costs of £31,629.40 at an average hourly rate of £344.92.

Disbursements totalling £3,031 98 have been incurred which are comprised of the costs of statutory advertising and the cost of the fidelity bonding

Fees totalling £30,000 plus disbursements have been drawn in respect of all four liquidations which will be paid by Alderande S A S. I do not intend to invoice any further costs.

# **Liquidation Closure**

The members were invited to consider the following resolutions



- 1 That the Liquidator's report and accounts to 16 September 2015 be and are hereby approved
- That the Liquidator is authorised to dispose of the Companies' books and records one year after the dissolution of the Companies.
- The Liquidator is released

The resolutions were all duly approved.
