THE DIRECTORS' REPORT

YEAR ENDED 31 MARCH 2012

The directors present their report and the financial statements of the company for the year ended 31 March 2012

Principal activity and business review

The principal activity of the business during the year is the supply of valuation services

The company specialises in the provision of property surveys and valuations. Clearly, the current period of economic uncertainty has had a significant effect on the UK mortgage market. Like many of our peers, we have experienced a higher level of speculative Professional Indemnity claims as lenders look to recover losses from non performing mortgages granted before the "credit crunch". The impact for JV Limited has been the significant increases in professional fees and internal costs associated with defending speculative cases rather than paying for successful claims. We are pleased that the level of speculative claims has started to reduce

We are satisfied that in this context turnover has remained consistent and the underlying trading results before claims remain profitable

1. Accounting policies

Basis of accounting

The financial statements have been prepared under the historical cost convention, and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

The financial statements have been prepared on a going concern basis, which assumes that the company will continue in operational existence for the foreseeable future, based on the continued support of its fellow group undertakings, directors and the company's bankers. The directors have prepared projections for the period to 31 March 2017. These projections have been prepared using assumptions which the directors consider to be appropriate to the current financial position of the company as regards to to current expected revenues and its cost base.

Whilst the directors are confident that these cashflow projections are reasonable based upon its assumptions, there can be no certainty of achieving them as a result of the unpredictable variations in the timing of the cashflows due to the nature of the company's business and the rapidly changing market

The directors therefore consider it appropriate to continue to prepare the financial statements on a going concern basis. The financial statements do not include any adjustments that may be necessary in the event that adequate funding was not made available.

Cash flow statement

The company has taken advantage of the exemption in FRS 1 from the requirement to produce a cashflow statement on the grounds that it is small company

Turnover

Turnover comprises revenue recognised by the company when a valuation report is issued, exclusive of value added tax

Tangible fixed assets and depreciation

Depreciation is calculated so as to write off the cost of an asset, net of anticipated disposal proceeds, over the useful economic life of that asset as follows

Motor vehicles

- 25% reducing balance

Office and computer equipment

- 33% reducing balance

The cost of tangible fixed assets is the purchase price together with any incidental costs of acquisition

Operating lease agreements

Rentals applicable to operating leases where substantially all of the benefits and risks of ownership remain with the lessor are charged against profits on a straight line basis over the period of the lease

1. Accounting policies (continued)

Deferred taxation

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date, where transactions or events that result in an obligation to pay more or a right to pay less tax in the future have occurred by the balance sheet date with certain limited exceptions

Deferred tax is calculated on an undiscounted basis at the tax rates that are expected to apply in the periods in which the timing differences are expected to reverse, based on tax rates and laws enacted or substantively enacted at the balance sheet date

Financial instruments

Financial instruments are classified and accounted for, according to the substance of the contractual arrangement, as either financial assets, financial liabilities or equity instruments. An equity instrument is any contract that evidences a residual interest in the assets of the company after deducting all of its liabilities.

Claims provision

The company provides for the estimated liability for claims where the customer has suffered a loss resulting from past valuations of properties that are proven to be the fault of the company

10. Related party transactions

Advantage has been taken of the exemption provided by the Financial Reporting Standard for Smaller Entities (effective April 2008) not to disclose transactions with fellow group companies as consolidated financial statements are prepared for the group and are publicly available

The J & E Shepherd partnership is related to the company as it has partners who have an interest in J & E Nominees Limited, a major shareholder in Shepherd Direct Limited the company's ultimate parent company. During the year the company purchased services totalling £549,903 (2011 £364,457) from the J & E Shepherd partnership. At the year end £16,669 (2011 £7,861) was owed to the J & E Shepherd partnership. The company made management charges and other recharges of £nil (2011 £81,420) to J&E Shepherd Partnership J & E Shepherd Partnership also owed the company £nil (2011 £81,785) at the year end

The company made recharges of £nil (2011 £920) to X-Bond Limited, a company in which P R Gratton and C C Hickling are both directors and shareholders. At the year end the company was owed £nil (2011 £nil) by X-Bond Limited in respect of these recharges.

In addition the company made management charges and other recharges of £nil (2011 £5,352) to Gasbox Limited, a company in which P R Gratton was a director. At the year end £nil (2011 £1,454) was owed to the company
