Clarke Willmott Limited (registered number 04502077) did not trade during the current or preceding period and has made neither profit nor loss, nor any other recognised gain or loss.


For the year ending 31 August 2015 the company was entitled to exemption from audit under section 480 of the Companies Act 2006 (Act) relating to dormant companies.
