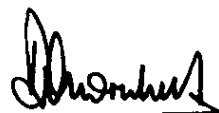

The affairs, business and property of the company are being managed by David Thornhill and Geoffrey Paul Rowley who were appointed Joint Administrators on 15 August 2011.

2. Introduction

2 1 I write, further to my appointment as Joint Administrator of the Company, to inform creditors of the conduct of the administration to date and to set out the Joint Administrators' proposals under Paragraph 49 of Schedule B1 to the Insolvency Act 1986

3. Circumstances giving rise to the appointment of the Joint Administrators

- 3.1 The Company was incorporated on 5 August 2002 following a restructuring of the GB Industries group. It traded from that date in the off-site design, manufacture and subsequent installation of relocatable and modular structural buildings and later developed expertise in the design, manufacture and installation of specialist, non-structural room "pods", for use in a variety of different building types, including hotels, residential and retail outlets.
- 3.2 The Company traded successfully for a number of years with the benefit of venture capital support from NVM which was the major shareholder in the Britspace group of companies and provided funding facilities to group companies. Whilst the Company made profits and generated cash it was subject to joint banking facilities with other group companies and supported losses made elsewhere in the group, particularly Gateway Chassis, Gateway Pods and Ultra Secure Products. In 2006 the Gateway Pods business was transferred within the group to come under the control of the Britspace management team. Ultimately the Gateway Chassis business was sold and Ultra Secure Products Limited was placed into administration in July 2009.
- 3.3 This resulted in NVM deciding that a re-structure of the group was necessary and that re-structuring took place in late 2009. NVM wrote off a significant amount of debt in some group companies and capitalised debt in others, resulting in a much stronger balance sheet in Britspace. The group was advised throughout this process by its auditor, PricewaterhouseCoopers, and its solicitors, Dickinson Dees. As a result of the re-structuring Britspace Modular Buildings Limited became the only trading company within the group and NVM provided further financial support by guaranteeing the Company's banking facilities with Lloyds Bank and providing performance and advance payment bonds to customers.
- 3.4 During December 2010 the management team of the Company forecast that the Company would require an additional £500,000 of cash to meet its ongoing obligations due to delays in securing payments from customers on key contracts and the effects of poor weather in December. The board worked with NVM and Lloyds Bank in order to secure this additional working capital facility which was achieved by Lloyds Bank increasing the company's overdraft which, in turn, was guaranteed by NVM. The company continued to experience difficult trading conditions during the first quarter of 2011 and creditor pressure started to build in February 2011. During this period advice was sought from PwC and Dickinson Dees regarding the financial position and the ability of the company to continue to trade as a going concern.
- 3.5 At a board meeting on 21 March 2011 NVM made the Company aware that it wished to end its involvement. PwC were appointed to seek a purchaser for the business with a view to securing a sale as a going concern. In the ensuing period pressure from creditors increased and further advice was obtained from both PwC and Dickinson Dees regarding the ability of the Company to continue to trade as a going concern. The directors concluded that the Company could continue to trade on the basis of the level of interest expressed by prospective purchasers of the business and recognising that a number of creditors had agreed to payment plans in respect of debts owed to them and in anticipation of debtor receipts being received on time.
- 3.6 At a board meeting held on 4 June 2011 the board approved an offer for the purchase of the entire share capital of the Company from TTC. The offer to purchase received from TTC indicated that investment funding of up to £3.75 million was available and following a period of due diligence the sale of the Company was completed on 17 June 2011. The Lloyds Bank facility was subsequently removed and replaced by funding provided by Pulse Cashflow Finance Limited ("Pulse"), initially at the level of £1 million.
- 3.7 It appears that, despite the sale and the forecast availability of funding the cash position of the Company continued to deteriorate throughout June and July. This was further exacerbated by a major customer cancelling a letter of intent on 24 June, and an existing customer becoming

insolvent owing the Company £150,000, although cash flow forecasts produced showed a manageable position to the end of July 2011 subject to continued support from creditors.

- 3.8 Negotiations were continuing throughout this period with a major customer regarding settlement of an outstanding claim for works done and the directors remained hopeful that further investment from TTC would be made available, along with further funding from Pulse after an initial 8-12 weeks satisfactory trading.
- 3.9 During late July and early August it became apparent that there were difficulties in collecting cash from customers. A verbal agreement with the major customer mentioned above regarding settlement of a claim was reached which was subsequently amended offering to settle the claim for in excess of £400,000 by payment of £155,000 immediately and the balance in March 2012. A revised payment plan in respect of arrears owed to HM Revenue and Customs was also rejected by them in the last week of July.
- 3.10 As a consequence on 3 August 2011 the company's future cash flow was reassessed and the board concluded that the company could not continue to trade as a going concern without significant further cash investment through TTC's continuing discussions with potential new investors.
- 3.11 In the meantime the directors of the Company approached Baker Tilly for advice regarding potential insolvency. As a result of the advice received the directors issued a notice of intention to appoint Mark Ranson and Philip Pierce of Baker Tilly as administrators on 8 August 2011 in order to protect the Company whilst further discussions with potential investors took place. Those discussions continued throughout the week commencing 8 August 2011.
- 3.12 As the holder of the first ranking qualifying floating charge registered against the Company Pulse were served with the notice of intention to appoint administrators. Pulse informed the Company that it intended to appoint administrators of its own choice should negotiations with new investors fail and Geoff Rowley of FRP was asked to attend a meeting at the Company on Wednesday 10 August to discuss the up to date position. By Friday 12 August it was clear that offers of funding that were acceptable to all the parties concerned would not be forthcoming and consequently Pulse exercised its right to appoint administrators on Monday 15 August 2011 when Geoffrey Paul Rowley and David Thornhill of FRP were appointed joint administrators.
- 3.13 During the week commencing 8 August 2011 the directors sought advice from Baker Tilly as to their actions during the period leading up to an appointment of administrators. The Company effectively slowed its trade to a minimum and sought advice from Baker Tilly in respect of order placement, payments and employee issues. During this time Baker Tilly were requested to start the process of identifying, alongside management, potentially interested parties. Given the company had been through a sale process only a few months before management were able to assist Baker Tilly in putting together a list of some 15 or so parties who it was thought may be interested in acquiring the business as a going concern.
- 3.14 It is understood that agents were instructed to conduct a valuation of the Company's assets and solicitors were requested to draw up a draft sale contract for use in the event that a quick sale could be achieved. When FRP became involved on 10 August Baker Tilly were informed and they ceased to carry out any more formal work but were asked to provide information they had gathered to FRP. In addition to attending the premises on 10 August FRP continued to liaise with the directors, TTC and Pulse regarding the ongoing negotiations with potential investors and made preparations for their potential appointment if negotiations with new investors were to fail. This included liaison with Baker Tilly, solicitors and chattel agents.
- 3.15 By 15 August trading had effectively stopped as it was felt that no further orders for goods should be made and materials available for use in the manufacturing process had run out. On the morning of 15 August, prior to the appointment of joint administrators, a staff meeting was held and all staff

with the exception of a number of administrative personnel were asked to go home and report for work again on Tuesday 16 August 2011

- 3 16 On the sale of the business in June 2011 to TTC all directors, with the exception of David Harris (managing director), resigned their office but continued to be employees of the Company. Mr Levett of NVM had been appointed as a director to represent NVM's interest but had never been an employee of the Company. At that point Chris Huckle of TTC was appointed as a director (and Executive Chairman) of the Company.
- 3.17 There have been no significant sales of assets in the period leading up to the appointment of the Joint Administrators.
- 3 18 Notice of the Intention to Appoint Administrators was issued on 8 August 2011 and was served on the holders of qualifying floating charges, being:
- Pulse Cashflow Finance Limited
 - TTC 1 LLP
- 3 19 The appointment of the joint administrators was made on 15 August by Pulse Cashflow Finance Limited, being the holder of the first ranking qualifying floating charge

4. The conduct of the Administration

4.1 The objectives of administration are:-

- A To rescue the Company as a going concern, failing which
- B. To achieve a better result for the Company's creditors as a whole than would be likely if the Company were wound up (without first being in administration), failing which
- C. To realise property in order to make a distribution to one or more secured or preferential creditors.

4.2 Immediately following our appointment as Joint Administrators, Geoff Rowley and I took steps to contact as many interested parties as possible to ascertain whether they may be interested in acquiring the business of Britspace as a going concern. As detailed above, the business had gone through a sales process earlier in 2011 and as a result there was an existing database of parties that had expressed an interest in acquiring the business at that time. In addition we received details of those interested parties identified by Baker Tilly.

4.3 Because of the financial position of the Company, the fact that employees had been sent home on 15 August 2011 (prior to our appointment), and due to the nature of the contracts undertaken by the Company a deadline of 1pm on Friday 19 August 2011 was set for the receipt of offers from interested parties. At the time of the deadline 4 offers had been received by the Joint Administrators. Contact was attempted with each of the companies concerned and it soon became clear that only two of these offers were serious, one other being for a sum below the break-up value of the assets and no further contact being received from the fourth interested party.

4.4 The remaining 2 offers were considered by the Joint Administrators, in conjunction with the charge holder and Leslie Keats (Quantity Surveyors acting on behalf of both parties) and detailed negotiations were commenced with one of the parties. A sale was agreed in principle and the interested party provided with a period of exclusivity in which to conduct due diligence. During that process the interested party became concerned that an acquisition of the business would require a greater level of working capital funding than originally thought. As a consequence the offer was withdrawn on 24 August 2011.

4.5 The Joint Administrators made contact with the remaining interested party and they confirmed that they were still interested in acquiring the business as a going concern. As a result negotiations were entered into with them and a sale agreed, again subject to due diligence. Unfortunately it became apparent shortly thereafter that they would be unable to proceed with an acquisition due to the fact that their funding for the purchase had, in turn, been withdrawn.

4.6 Due to the amount of time passing, the notification by a large number of customers that contracts had been terminated and the lack of available working capital to allow the company to trade the Joint Administrators concluded that a sale of the business as a going concern would not be possible. Consequently the administrators have proceeded to wind-down the company in an orderly manner. All remaining interested parties were contacted requesting that they confirm what, if any, part of the business they were interested in acquiring. All replies were collated and passed to our agents, Edward Symmons, to progress.

4.7 At the same time a large number of pods, some complete and some part-complete have been disposed of to customers who requested delivery notwithstanding the fact that the Company would be unable to complete the contracts in full. A number of employees were retained by the administrators to assist them in this process. All those pods that have been disposed of have been sold at the best possible price achievable in order to maximise the recovery for the administration process.

- 4.8 In addition, the remaining work in progress in the factory related to a contract to build five modular restaurants for McDonalds. Of the restaurants one was some 60% complete at the time of our appointment and the remaining four all had floor plates laid but no super-structure in place. Meetings were held with McDonalds to explore the possibility of the administrators completing the first two restaurants which were required to be in situ within a few weeks. Whilst McDonalds were very cooperative in these discussions it became apparent that the costs of completing the buildings would be far in excess of the remaining amount available under the original contract terms. McDonalds were unwilling to commit further expenditure in favour of the Company and appointed a third party to complete the buildings for them. A sale of the work in progress in the sum of £215,000 plus VAT was agreed with McDonalds which allowed the third party contractors to attend the site in order to remove the part-completed buildings. This process was completed on 28 September 2011.
- 4.9 A large number of creditors lodged claims to retention of title to goods that had been supplied to the Company in the period leading up to the administration. All these creditors have been contacted and further information obtained relating to the claims. All the claims have now been reviewed by the joint administrators and where found to be valid the creditors concerned have been allowed access to the premises in order to collect their goods. The remaining stock items have either been sold to customers or remain in the hands of our agents to be disposed of in due course.

Employees

- 4.10 At the date of appointment of the Joint Administrators the Company had 228 employees employed on both a full and part time basis. As the Joint Administrators were not in a position to continue trading the business whilst seeking a buyer and were not in funds to pay any wages all staff were sent home until 19 August 2011 when an update was expected.
- 4.11 As a result of the interest shown in acquiring the business by 19 August 2011 and in a bid to preserve the value of the business no redundancies were made at that time and staff were further requested to wait at home pending the outcome of negotiations.
- 4.12 As a result of the negotiations that took place between 19 and 23 August 2011 it became apparent that it was unlikely that a sale of the business was going to be achieved with the workforce in its entirety being retained. As a result approximately 190 staff were made redundant on 23 August 2011. The remaining members of staff were retained to assist the Joint Administrators either with head office functions or for the sale of pods. Some of those employees retained specifically with a view to completing the McDonalds contract were made redundant when it became apparent that the contract could not be completed by the Company. The remaining staff were retained in order to assist the administrators' agents in clearing the site and preparing for an auction of remaining stock and chattel assets. Further redundancies have been made in the period since 23 August as work has been completed. At the date of these proposals 2 members of full time staff remain on the payroll.

Premises

- 4.13 The site occupied by the Company at Gilberdyke, East Yorkshire was subject to a portfolio of 9 leases covering a total area of some 26 acres. As a result of the Joint Administrators undertaking a controlled wind-down of the Company's affairs it was concluded that not all the areas were required. In the light of the impending quarter date, 29 September, and the requirement to pay rent for the forthcoming quarter, the Joint Administrators, on behalf of the Company, entered into a licence with the landlord to occupy a number of areas on the site for a period of 5 weeks commencing 29 September 2011. The licence was completed on 28 September with a payment of £29,903.66 + VAT being made to the landlord in respect of the rent falling due for the period.

Sales

- 4 14 During the period since their appointment the Joint Administrators, in conjunction with Leslie Keats, have made sales totalling £361,462 88 in respect of Work in Progress ("WIP"). This WIP took the form of both completed and incomplete bathroom pods as well as the sale of part complete restaurants to McDonalds. All the WIP has now been sold and the Joint Administrators do not anticipate any further realisations being made other than in respect of remaining chattel assets which will be controlled by their agents, Edward Symmons

Debtors & Retentions

- 4 15 The debtor book and outstanding retentions on completed contracts have been claimed by Pulse under the terms of its invoice discounting facility with the Company. Leslie Keats has been instructed by Pulse and the joint administrators to assist in collecting the amounts due in order to discharge the outstanding liability. At the current time Leslie Keats has realised some £349,000 in respect of these book debts and retentions
- 4.16 It is anticipated that a further £276,000 may be recovered in respect of these book debts and retentions

Agents

- 4.17 Following their appointment the Joint Administrators instructed independent valuers, Edward Symmons, to value the tangible assets and stock of the Company
- 4 18 Since the decision to undertake a controlled wind-down of the Company, Edward Symmons have sold assets valued at £85,000 for the sum of £100,050 + VAT. Of this sum £16,760 + VAT has been received to date and is being held by Edward Symmons on behalf of the Joint Administrators.
- 4.19 The remaining chattel of the company are all under the control of Edward Symmons and they are in the process of arranging sales directly to interested parties where possible. All other assets are being placed in an e-auction to take place during October 2011.
- 4.20 A copy of the Joint Administrators' receipts and payment account to date is attached as Appendix B. This shows that total receipts of £436,870 55 have been made in the period since the start of the administration. Included in this amount are realisations totalling £52,471.69 in respect of book debts which may be payable to Pulse in due course
- 4 21 Payments totalling £75,368 51 have also been made in the period the majority of which relates to the payment of wages to staff employed during the period as referred to above.

5. Administrators' proposals

- 5.1 The Administrators' proposals in accordance with Paragraph 49 of Schedule B1 to the Insolvency Act 1986 to achieve objective (b) of the administration, are attached as Appendix C.
- 5.2 It is envisaged that objective (a) cannot not be achieved due to the fact that despite offers being received and a sale of the business agreed, the potential purchaser withdrew their interest as they considered the potential TUPE liability (in respect of employment contracts) and working capital required rendered the business unviable

6. Creditors' meeting

- 6.1 Based on the information currently available, the Joint Administrators consider that the Company has insufficient property to enable a distribution to be made to unsecured creditors. They are therefore not required to call a creditors' meeting pursuant to Paragraph 51 of Schedule B1 of the Insolvency Act 1986. The Administrators must however summon a meeting if requested to do so by creditors whose debts amount to at least 10% of the total debts of the Company. The request must be in the prescribed form (form 2.21B) and be made within 8 business days of the date of this report, in accordance with Rule 2.37(1) of The Insolvency Rules 1986 (as amended).
- 6.2 In accordance with Rule 2.33(5) of The Insolvency Rules 1986 (as amended), where the Administrators have not called a creditors' meeting, the proposals set out below will be deemed to have been approved by the creditors unless at least 10% by value of the creditors requisition a meeting of creditors within 8 business days of the date of this report

7. Administrators' remuneration

- 7.1 The Administrators' remuneration after the date of appointment will be drawn from the Company assets and it is proposed that it will be charged on a time cost basis. Details of FRP Advisory LLP charge out rates are included at Appendix D.
- 7.2 The Administrators' disbursements are a recharge of actual costs incurred by the administrators on behalf of the Company
- 7.3 Creditors have a right to request further information from the Administrator under Rule 2.48A of the Insolvency Rules 1986 and further have a right to challenge the Administrators' remuneration and other expenses under Rule 2.109 of the Insolvency Rules 1986 following receipt of a progress report. Further details of these rights can be found in the Creditors' Guide to Fees which you can access by using the following link <http://cp.frpadvisory.com> and select the one for administrations. Alternatively a hard copy of the relevant guide will be sent to you on request.
- 7.4 Details of the time charged to this case to date, analysed between the different types of work undertaken, are enclosed at Appendix E. The basis of the Administrators' remuneration has not yet been approved by creditors, and the Administrators have accordingly not drawn any remuneration in this case
- 7.5 You will note that in the period from 15 August 2011 until 30 September 2011, £251,248.90 of time costs have been incurred which equates to some 1,101.17 hours of time
- 7.5 The Administrators' fees for dealing with the assets subject to security will be agreed with Pulse.

8. Pre-Administration costs charged or incurred by the Administrators and Baker Tilly

- 8.1 The Company made a payment to Baker Tilly of £50,000 on account of its pre-appointment work. The payment was made on or around 5 August 2011. I understand that Baker Tilly issued a letter of engagement on 8 August 2011 in which it estimated its pre-appointment costs would be £55,000 together with £2,500 for agents and £5,000 for solicitors. Baker Tilly also acknowledged in its engagement letter receipt of £50,000 as a deposit for costs. Since the date of my appointment Baker Tilly have drawn fees in respect of its own costs totalling £34,099.17 plus VAT. In addition the balance of the payment on account has been utilised to pay solicitors £4,567.50 plus VAT and agents £3,000 plus VAT. These fees have been paid from the balance of monies paid to Baker Tilly prior to the date of my appointment but they were not drawn until after 15 August 2011. I am still investigating the circumstances surrounding the payment made to Baker Tilly and will seek approval for payment of their agreed costs from the necessary creditors in due course.
- 8.2 Attached at Appendix F is a statement of pre-administration costs charged or incurred by the Joint Administrators and their solicitors.
- 8.3 In respect of FRP Advisory's pre-administration costs, these total £16,469.90 which includes time costs of £16,184 and expenses of £285.90 which had not been paid when the Company entered administration.
- 8.4 In respect of PDT Solicitors pre-administration costs, these total £5,529.15 which includes time costs of £5,171.50 and disbursements of £357.65 which had not been paid when the Company entered administration.

9. The Directors' Statement of Affairs

- 9.1 Shortly after the appointment, the directors of the Company were asked to submit a statement of affairs under paragraph 47 of Schedule B of the Insolvency Act 1986. A draft statement of affairs has been received but the information contained therein is still to be finalised by the directors. A copy of the draft statement of affairs is attached as Appendix G to this report.

10. Prescribed part

- 10.1 The Administrators have considered the possibility of a prescribed part for unsecured creditors under S176A of the Insolvency Act 1986.
- 10.2 Based on information available at the current time it appears the net property available for the prescribed part will be less than £10,000 and therefore there will be no prescribed part distribution to unsecured creditors. Creditors will be advised accordingly if this position changes.

11. Outcome for secured creditors

- 11.1 At the date of the Joint Administrators' appointment, Pulse were owed the sum of £960,099 in respect of monies advanced to the Company under the terms of its invoice discounting agreement and contractual charges. This amount may increase due to the addition of termination charges allowed under the finance agreement.
- 11.2 Based on the information available to date it is anticipated that Pulse may recover approximately £939,000 from realisations covered by its fixed charge. It is not anticipated that it will make any realisation under its floating charge.

- 11 3 TTC hold a floating charge over the assets of the Company. It is not anticipated that any funds will be available for TTC under its floating charge

12. Outcome for preferential creditors

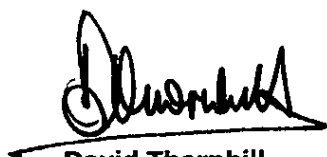
- 12 1 The statement of affairs shows preferential creditors of £290,000, being employees for arrears of pay (capped at £800 per employee) and outstanding holiday pay.
- 12 2 It is not anticipated that preferential creditors will be paid a dividend in respect of amounts owing to them

13. Outcome for unsecured creditors

- 13 1 The statement of affairs indicates that, subject to costs, a dividend will not be available to unsecured creditors

14. Directors' conduct

STATEMENT OF THE PROPOSALS OF THE JOINT ADMINISTRATORS OF BRITSPACE MODULAR BUILDINGS LTD (IN ADMINISTRATION)

PURSUANT TO PARAGRAPH 49(1) OF SCHEDULE B1 TO THE INSOLVENCY ACT 1986 (The Act) AND RULE 2.33 OF THE INSOLVENCY RULES 1986 (The Rules)

1. The Joint Administrators think that objective (a) of the administration, as detailed in Paragraph 3(1) of Schedule B1 to the Insolvency Act 1986, will not be achieved due to the fact that despite offers being received and a sale of the business agreed the potential purchaser withdrew their interest as they considered the potential TUPE liability and working capital required rendered the business unviable. As such, it is envisaged that objective (b) will be achieved, a better result for the Company's creditors as a whole than would be likely if the Company had been wound-up (without first being in administration)
2. The Joint Administrators make the following proposals for achieving the objective set out above:
 - a) They continue to manage the business, affairs and property of the Company in order to achieve the purpose of the Administration. In particular that they:
 - i. Dispose of the Company's ownership of such assets at such time(s) on such terms as they consider expedient
 - ii. Investigate and, if appropriate, pursue any claims that the Company may have against any person, firms or company whether in contract or otherwise, including any officer or former officer of the Company or any person, firm or company which supplies or has supplied goods or services to the Company
 - iii. In addition, they do all such things and generally exercise all their powers as Administrators as they in their discretion consider desirable or expedient in order to achieve the purpose of the administration or protect and preserve the assets of the Company or maximise the realisations of those assets, or of any purpose incidental to these proposals.
 - b) The administration shall continue (subject to the statutory provisions relating to automatic termination) until the realisable assets of the Company have been realised and all liabilities incurred during the administration have been discharged or until such a time as deemed appropriate by the Administrators. At this stage the Company shall be dissolved or placed into liquidation as outlined below.
 - c) The administration may be extended by six months prior to the one year anniversary pursuant to paragraph 76 of Schedule B1 to the Act.
 - d) If they think the Company has no property which might permit a distribution to its unsecured creditors, or if they also consider that an exit from the administration into liquidation is not appropriate they will send a notice to the Registrar of Companies in accordance with Paragraph 84 of Schedule B1 to the Insolvency Act 1986 and three months after the filing of the notice the Company will be deemed to be dissolved
 - e) If they are of the view that it is appropriate for the Company to move from administration into liquidation, whether compulsory or voluntary, the Joint Administrators be authorised to take steps to place the Company into whichever liquidation process they, at their discretion, deem appropriate. Pursuant to Paragraph 83 of Schedule B1 to the Insolvency Act 1986,

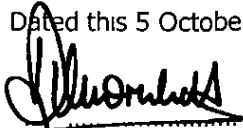
should the creditors not nominate a Liquidator; the proposed Liquidators are to be David Thornhill and Geoffrey Paul Rowley. Any act to be done by the Joint Liquidators may be done by all or any one of them. Pursuant to Para 83(7)(a) and Rule 2.117A(2)(b) of the Insolvency Rules 1986, creditors may nominate a different person as the proposed Liquidator, provided that the nomination is made after the receipt of these proposals and before these proposals are approved.

As the Joint Administrators consider that the Company has insufficient property to enable a distribution to be made to the unsecured creditors, the following sections of the Administrators' proposals, (f, g and h) will require the consent of each secured creditor and the majority of voting preferential creditors (as appropriate):

- f) The Joint Administrators' fees plus VAT should be approved on a time cost basis charged at the charge out rates prevailing at the time the work is undertaken, to be drawn when the Joint Administrators see fit. A schedule of current charge out rates are set out in Appendix D.
- g) The Joint Administrators' discharge from liability shall take effect in accordance with Paragraph 98 of Schedule B1 to the Act 30 days following either the Company entering into liquidation or filing the notice of moving from administration to dissolution.
- h) **This resolution is subject to approval under the Insolvency Rules 1986 Rule 2.67A and is not part of the proposals subject to approval under Paragraph 53 of the Insolvency Act 1986**

That the unpaid pre-administration costs as set out in Appendix F are approved and that the Joint Administrators be authorised to draw such sums from any funds in hand as an expense of the administration to be drawn when the Joint Administrators see fit.
