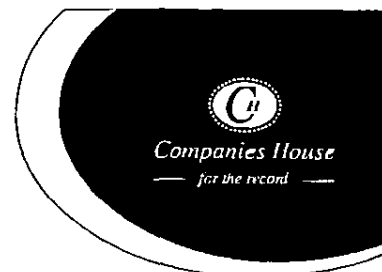

Figure 1. Schematic representation of the experimental design. The subjects were divided into two groups: the control group (CG) and the experimental group (EG). The CG was exposed to a control environment (CE) and the EG was exposed to an experimental environment (EE). The EE was designed to simulate a real-world environment with various stimuli (e.g., visual, auditory, and olfactory) and a complex task (e.g., navigation and decision-making). The subjects were exposed to the EE for a period of 24 hours. The results of the experiment are shown in the bar chart, which displays the mean values of the variables measured for each group. The error bars represent the standard deviation. The statistical significance of the differences between the groups is indicated by the asterisks (\*).
