## EXECUTION VERSION

### SECURITY ACCESSION DEED

THIS SECURITY ACCESSION DEED (this Deed) is made on **5 March 2024**

#### BETWEEN:

- (1) **MINERVA BIDCO LIMITED**, a company incorporated in England and Wales with registered number 11279441 (the **Company**);
- (2) Each entity listed in Schedule 1 to this Security Accession Deed (each, an **Additional Chargor** and together, the **Additional Chargors**); and
- (3) **KROLL TRUSTEE SERVICES LIMITED** as security trustee for itself and the other Secured Parties (the **Security Agent**).

#### RECITAL:

This deed is supplemental to a debenture dated 15 November 2023 between the Chargors named therein and the Security Agent, as previously supplemented by earlier Security Accession Deeds (if any) (the **Debenture**).

NOW THIS DEED WITNESSES as follows:

#### 1. INTERPRETATION

##### 1.1 Definitions

Terms defined in the Debenture shall, unless the context otherwise requires or unless otherwise re-defined below, have the same meaning when used in this deed.

##### 1.2 Construction

Clauses 1.2 (Construction) to 1.10 (Permitted Transactions and releases) of the Debenture will be deemed to be set out in full in this deed, but as if references in those clauses to the "Debenture" and other similar expressions were references to this deed.

#### 2. ACCESSION OF ADDITIONAL CHARGORS

##### 2.1 Accession

Each Additional Chargor agrees to be a Chargor for the purposes of the Debenture with immediate effect and agrees to be bound by all of the terms of the Debenture as if it had originally been a party to it as a Chargor.

##### 2.2 Covenant to pay

Each Additional Chargor as primary obligor covenants with the Security Agent (for the benefit of itself and the other Secured Parties) that it will on demand pay or discharge its Secured Obligations when they fall due in the manner provided for in the Secured Debt Documents.

##### 2.3 Specific Security

Subject to Clause 1.7 (Excluded Assets) of the Debenture, each Additional Chargor, as continuing security for the payment of its Secured Obligations, charges in favour of the Security Agent with full

title guarantee the following assets, both present and future, from time to time owned by it or in which it has an interest by way of first fixed charge:

- (a) all its Shares and all corresponding Related Rights;
- (b) all monies standing to the credit of the Accounts and all of its rights, title and interest in relation to those accounts.

## **2.4 Floating Charge**

- (a) As further continuing security for the payment of its Secured Obligations, subject to Clause 1.7 (Excluded Assets) of the Debenture, each Additional Chargor (other than a Foreign Chargor) charges with full title guarantee in favour of the Security Agent by way of a floating charge all its present and future assets, undertakings and rights.
- (b) Without prejudice to Clause 1.7 (Excluded Assets) of the Debenture, paragraph 14 of Schedule B1 to the Insolvency Act 1986 shall apply to the floating charge created pursuant to paragraph (a) above.

## **2.5 Implied covenants for title**

The Security created under this Deed is made with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994 (other than as permitted or not prohibited under the Secured Debt Documents).

## **3. NEGATIVE PLEDGE**

Each Additional Chargor may not:

- (a) create or permit to subsist any Security upon any part of the Charged Property where such Security is securing any Financial Indebtedness; or
- (b) sell, transfer, lease out, lend or otherwise dispose of all or any part of the Charged Property,

except as permitted under or not prohibited by the Secured Debt Documents or otherwise with the prior consent of the Security Agent (acting on the instructions of the Instructing Group).

## **4. CONSTRUCTION OF DEBENTURE**

- (a) The Debenture shall remain in full force and effect as supplemented by this Deed.
- (b) The Debenture and this Deed shall be read together as one instrument on the basis that references in the Debenture to "this deed" or "this Debenture" and other similar expressions will be deemed to be references to the Debenture as supplemented by this Deed.

## **5. DESIGNATION AS A FINANCE DOCUMENT**

This Deed is designated as a Finance Document for the purposes of the Senior Facilities Agreement.

## **6. FAILURE TO EXECUTE**

Failure by one or more parties (Non-Signatories) to execute this Deed on the date hereof will not invalidate the provisions of this Deed as between the other Parties who do execute this Deed. Such Non-Signatories may execute this Deed on a subsequent date and will thereupon become bound by its provisions.

**7. GOVERNING LAW**

- (a) This Deed (and any dispute, controversy, proceedings or claims of whatever nature arising out of or in any way relating to this deed or its formation) and obligations of the Parties hereto and any matter, claim or dispute arising out of or in connection with this Deed (including any non-contractual claims arising out of or in association with it) shall be governed by and construed in accordance with English law.
- (b) The Parties agree that the courts of England shall have exclusive jurisdiction to settle any dispute arising out of or in connection with this deed, whether contractual or non-contractual (including a dispute regarding the existence, validity or termination of this Debenture) (a **Dispute**). The Parties agree that the courts of England are the most appropriate and convenient courts to settle Disputes and accordingly no party will argue to the contrary.




