

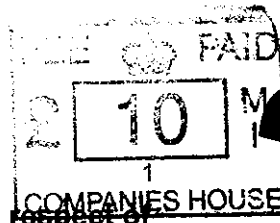

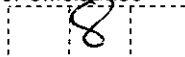

Short particulars of all the property mortgaged or charged

1 By way of legal mortgage:-
