Subject to the applicable statutes, the company may by ordinary resolution declare dividends in accordance with the respective rights of the members, but no dividend shall exceed the amount recommended by the directors. Subject to the applicable statutes, the directors may pay interim dividends to the members if it appears to them that they are justified by the profits of the company available for distribution. If the company is wound up, the Liquidator may, with the sanction of a special resolution of the company and any other sanction required by the companies act 2006, divide among the members in specie the whole or any part of the assets of the company and may, for that purpose, value any assets and determine how the division shall be carried out as between the members or different classes of members. The liquidator may, with the like sanction, vest the whole or any part of the assets in trustees upon such trusts for the benefit of the members as he with like sanction determines, but no member shall be compelled to accept any assets upon which there is a liability. No ordinary shares in issue are to be redeemed or liable to be redeemed at the option of the company or any holder, but subject to applicable statute shares may be issued which are to be redeemed or are liable to be redeemed at the option of the company or the holder on such terms and in such manner as may be provided by the company's articles of association.</p>


