Report of the Trustees for the year ended 30 November 2007

The Trustees present their report and financial statements for the year ended 30 November 2007

Charitable Objectives

The charity's objectives are to promote the relief of illness, disability and suffering in such ways as the Charity from time to time think fit without regard to race, nationality, creed, age, gender or sexual orientation and without geographical restriction and in particular, but without prejudice to the generality of such objects -

- (a) by establishing a self-regulatory professional association for weight management clinics for the proper care, treatment and education of persons who are suffering obesity ("the beneficiaries"),
- (b) by conducting or promoting or encouraging research and evaluation into the care, welfare, treatment and support of the beneficiaries and the dissemination of knowledge,
- (c) by providing or encouraging or assisting in the teaching or training of any person connected with the care, treatment or welfare of the beneficiaries and by providing or facilitating the provision of vocational training or other training services to such persons,
- (d) to provide advice and assistance to others on matters within the objects of the charity either free of charge or subject to such payment as the charity may think fit

Constitution

Obesity Management Association is a company limited by guarantee (number 4583585) and obtained charity status on 11 May 2004 (number 1103678) Its Memorandum and Articles of Association form its governing document. Under those Articles, the members of the Management Committee are empowered at any time to appoint any person to be a member of the Council, but any member so appointed shall hold office only until the next following annual general meeting, and shall then be eligible for re-election

Review of Activities

The year ending 30th November 2007 was another challenging year for the Association, and as in previous years the Association viewed such challenges as opportunities

The Association's Parliamentary relations activity during the year included engagements with both Government and Opposition parties to establish an increased understanding of the Association's role and the position Members play in the treatment of overweight and obese patients

Report of the Trustees for the year ended 30 November 2007 (Continued)

As part of this work OMA was requested to prepare a report by the Shadow Minister for Health on the private health sector's ability to respond to the need to provide treatment for private patients. This report identified the role of the private sector in the need to introduce inclusive weight management programmes and the importance of establishing positive working relationships with the NHS. In addition the report contained positive treatment cost comparisons between the private sector and the NHS, together with an outline of a new policy in the treatment of children.

The subject of, and dangers associated with, the sale and purchase of class 3 drugs on the internet continues to occupy the OMA board whose concerns were expressed to both Government and opposition parties who welcomed and recognised this as being a serious problem. Despite this dialogue with parliamentarians and officials OMA is not optimistic that action will be taken to change legislation to prohibit the sale of such drugs via the internet.

The Association's discussions with the Healthcare Commission regarding the release of information resulted in the Commission refusing to release copies of their "expert reports" in relation to the conduct of three members which they have reported to the GMC Fitness to Practice Committee OMA then approached the Information Commissioner who defended the Commissions right not to release the reports OMA had requested

Members agreed to appoint, on a short term contract, a public relations consultancy to assist the Association to present its position over a wide range of health and weight management related topics through the media

OMA's discussions with Thames Valley University and its commitment to continuous professional development (CPD), progressed and the proposed Masters Degree in Bariatric Medicine will proceed once funding has been established

The year ahead once again looks as though it will be another exciting and positive year for OMA

Financial Review

Membership fees and voluntary income donations were down 8% on the year and expenditure decreased by 11% The Trustees are comfortable with the level of expenditure and total funds increased by 16% at the end of the financial year OMA is financially sound and in a good position to achieve its short term objectives

Reserves Policy

The Trustees have reviewed the charity's needs for reserves in line with guidance issued by the Charity Commission. It is considered that the target for free reserves should remain at a level which represents six months projected operating expenditure. At the balance sheet date free reserves stand at approximately twelve months projected expenditure and are therefore higher than the reserves policy.

Trustees Responsibilities

Company law requires the Obesity Management Association to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the company and of the surplus or deficit of the company for that period In preparing those financial statements, the Council of Management is required to

- select suitable accounting policies and then apply them consistently,
- make judgements and estimates that are reasonable and prudent,
- state whether the policies adopted are in accordance with the appropriate SORP on Accounting for Charities and Accounting Regulations and with applicable accounting standards, subject to any material departures disclosed and explained in the financial statements, and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply with the Companies Act 1985 They are also responsible for safeguarding the assets of the company, including taking reasonable steps for the prevention and detection of fraud and other irregularities
