## 1. Accounting policies

#### 1.1 Going concern

The Directors have reviewed the Company's current position following the preparation of the management accounts to the month end prior to signing these financial statements and in particular have considered the impact of Covid-19.

Whilst lock down restrictions caused disruption to everyone's travel plans the financial impact on the Company has been offset by the subsequent increase in demand for UK staycation holidays and extra appeal for the travel flexibility offered in a self-contained Motorhome. The sector as a whole has since seen unprecedented sales demand throughout UK and Europe.

During lock down periods the Company also had the flexibility to operate with minimal overheads as it does during every off-peak season. The overall profitability of the Company has not been adversely affected by the impact of Covid-19 and the Directors have concluded that the Company has adequate resources to continue in operation for the foreseeable future and therefore continue to adopt the going concern basis of accounting in preparing these financial statements.
