IT IS ORDERED THAT:

Transfer

1. The proceedings listed in Schedule 1 to this Order be transferred to the High Court for the purposes of this application only and forthwith after the making of this Order be transferred back to the Court from which they came.

Bankruptcies

2. Pursuant to Section 298 of the Act and Rule 12.36(2) of the Rules, the Respondent be removed from her office as Trustee in Bankruptcy of the individuals identified in Schedule 2 hereto with immediate effect.
3. Pursuant to Section 298 and 303(2) of the Act and Rule 12.36 (2) of the Rules the Second Applicant be appointed as joint trustee in place of the Respondent with immediate effect.

Creditors Voluntary Liquidation

4. Pursuant to Section 108 (2) of the Act and Rule 12.36(2) of the Rules the Respondent be removed from her office as Liquidator of the companies listed in Schedule 3 as being companies in Creditors Voluntary Liquidation with immediate effect.
5. Pursuant to Section 108 (2) of the Act and Rule 12.36(2) of the Rules the Second Applicant be appointed as Liquidator of the companies listed in Schedule 3 in place of the Respondent with immediate effect.

Members Voluntary Liquidation

6. Pursuant to Section 108 (2) of the Act and Rule 12.36(2) of the Rules the Respondent be removed from her office as Liquidator of the companies listed in Schedule 4 as being companies in Members Voluntary Liquidation with immediate effect.
7. Pursuant to Section 108 (2) of the Act and Rule 12.36(2) of the Rules the First Applicant be appointed as Liquidator of the companies listed in Schedule 4 in place of the Respondent with immediate effect save for Cyphers Indoor Bowling Company Limited (company number 00312671) in which case the Second Applicant be appointed as Joint Liquidator with the First Applicant in place of the Respondent with immediate effect.

Administrations

8. Pursuant to paragraph 88 of Schedule B1 to the Act and Rule 12.36(2) of the Rules the Respondent be removed from her office as Joint Administrator of Fan Data Pools Limited (company number: 10805957) being a company in Administration with immediate effect.
9. Pursuant to paragraph 63 of Schedule B1 to the Act and Rule 12.36(2) of the Rules the Second Applicant be appointed as Joint Administrator of Fan Data Pools Limited (company number: 10805957) with immediate effect.

11. The Applicants shall notify the Secretary of State of this Order as soon as reasonably practicable after it is made.
12. The Applicants shall ensure that a sealed copy of this Order and every Order which may be made as a result of the Application is lodged with the court having jurisdiction over each case affected by such orders for filing on the court file relating to that case.
13. Within 28 days of this Order, the Applicants shall give notice of this Order to all the creditors of the companies and individuals listed in the Schedules to this Order by way of advertisement in the *London Gazette*.
14. All creditors of the companies, or in the case of any members voluntary liquidation, any member, and individuals listed in the Schedules to this Order shall have permission to apply within 28 days of the said advertisement in the *London Gazette* to vary or discharge this Order insofar as it affects the company, or companies or bankrupts' estates of which they are a creditor. Any such application shall be made on 3 clear days' notice to the Applicants.
15. The provisions contained in IR r.18.7(4) and r.18.8(3) shall not apply and neither the Respondent nor the Applicants are required to produce any progress reports on the Respondent ceasing to act as an office-holder pursuant to this Order. Each of the insolvencies in the Schedules to this Order shall retain their original reporting dates.

Costs

16. The costs of this application shall be borne by the Applicants and neither the Applicants nor the Respondent shall have recourse to the insolvency estates of any of the companies and individuals listed in the Schedules to this Order for the purposes of satisfying their costs of this application.
