At the balance sheet date the company had negative shareholders funds of £222,257 (2016: £224,818). Consequently, the company is dependent on the continued support of its director and shareholder, who has given her personal assurances that she will provide all the financial assistance to enable the company to continue and meet its ongoing obligations as they fall due. On this basis, the director consider it appropriate to prepare the financial statements on the going concern basis. The financial statements do not include any adjustments that would result from a withdrawal of the assurances given by the director and shareholder.

At the balance sheet date the company owed the director £211,844 (2016:£204,165).

The company uses two properties owned by the director under five year leases dated 1st October 2013 and 6th April 2015 respectively. For the year ended 31 January 2017, £10,169 rent was payable and at the balance sheet date no amount was outstanding. The company leased the properties to third parties at a commercial full market.

Mark Adam Fashions Limited is a private company limited by shares incorporated in England and Wales. The registered office is Kenton House, 666 Kenton Road, Harrow, Middlesex, HA3 9QN.

The director of the company has elected not to include a copy of the profit and loss account within the financial statements.

For the year ended 31 January 2017 the company was entitled to exemption from audit under section 477 of the Companies Act 2006.

The director acknowledges her responsibilities for complying with the requirements of the Act with respect to accounting records and the preparation of financial statements.

The members have not required the company to obtain an audit of its financial statements for the year in question in accordance with section 476.
