
- select suitable accounting policies and then apply them consistently,



1 Accounting policies**1.1 Basis of Preparation**

9 Related party disclosures

C Taylor, Director of the company is also an employee of Alpha Real Property Investment Advisers LLP (Alpha). Alpha administers the operating partnerships in which the company had an interest during the year. For this service Alpha receives fees as stated below:

- 2.5% p.a. on Residential Development Partnership Capital
- 2.5% p.a. on Commercial Development Partnership Capital
- 2.5% p.a. on Self Storage Partnership Capital
- 1.55% p.a. on Forestry Partnerships gross purchase costs

The former administrator, Close Asset Management Limited, charged initial fees on the subscribed share capital of 5.5%.

The ultimate controlling party holding 100% of the share capital is Stephen John Missen.
