## **Progress Report**

The statement of affairs showed cash in hand of the liquidator of £6,716 relating to a book debtor payment. Book debtors and retentions also showed an estimated realisable value of £9,900 and £12,000 respectively. Retentions totalling £1,806 have so far been realised. This is lower than anticipated due to the insolvency of two companies. Book debtors have also been pursued but, again, two large debts have been written off due to companies being placed into liquidation and administration.

## **Receipts and Payments**

I attach a summary of the receipts and payments account to 2 February 2013.

## **Remuneration**

Creditors authorised a statement of affairs fee of £5,000 plus VAT and this has been paid. Time costs to date amount to £8,592.50 represented by 16 partner hours and 25.5 administrator hours. The liquidator has not received any payment for the time expended in respect of the time costs.

## **Investigation**

I confirm that I have, as part of my duties as liquidator, investigated the affairs of the company and made an appropriate report to the Disqualification Unit of the Insolvency Service. This report is confidential and its contents cannot be disclosed.


## **Reason for Remaining Open**
