At these meetings this report will be presented to the creditors and members together with a final account showing the manner in which the winding up has been conducted, and also hearing any explanation that may be given in relation to the winding up. Once these meetings have been held the liquidation will be closed

Please note that these meetings are a statutory requirement and your attendance is not essential. If you do not wish to attend or vote at the meeting, then you need do nothing more, although I would be grateful if you could complete and return the enclosed proxy form

2 Receipts and Payments

I attach a final statement of receipts and payments for the liquidation covering the period from the date of the appointment, 3 February 2012 to 9 October 2013

3 Realisation of Assets

My annual report dated 26 February 2013 stated the case is open to facilitate book debtor collection. The statement of affairs recorded book debtors with a book value of £32,300 with an estimated to realise value of £21,900. Of these debts, four have entered into insolvency proceedings leading to the sum of £15,585 being written off. There were a number of set offs that led to further write offs and led to realisations of £5,703.

4 Conduct of the liquidation

I confirm that I have complied with my obligation to report to the DTI regarding the affairs of the company and its directors. The report is confidential between myself and the DTI and its contents cannot be disclosed to creditors.

5 Remuneration of Liquidator

Creditors authorised a statement of affairs fee of £5,000 plus VAT, together with the liquidator's remuneration to be on a time cost basis. Creditors should observe that the liquidator has received the statement of affairs fee

To date, my time costs amounts to some £10,470 represented by 19 partner hours and 32 administrative hours at an average charge out rate of £205 per hour. This is broken down as follows
