In relation to all of the Bankruptcies set out in Schedule B hereto, the First and Second Respondents be appointed in the place of the Applicant (such that where the Applicant is the sole office holder, the First and Second Respondents be appointed jointly in his place; where the Applicant is joint office holder with the First Respondent, he be replaced by the Second Respondent; where the Applicant is joint office holder with the Second Respondent, he be replaced by the First Respondent) such that they be joint Trustees of all the bankrupts' estates set out in the aforementioned Schedule;
- In relation to all of the Company Voluntary Arrangements set out in Schedule C hereto, the First and Second Respondents be appointed in place of the Applicant

(such that where the Applicant is the sole office holder, the First and Second Respondents be appointed jointly in his place; where the Applicant is joint office holder with the First Respondent, he be replaced by the Second Respondent; where the Applicant is joint office holder with the Second Respondent, he be replaced by the First Respondent) such that they be joint Supervisors of all of the aforementioned Company Voluntary Arrangements;

- 5. In relation to all of the Administration proceedings set out at Schedule D hereto, the First and Second Respondents be appointed in the place of the Applicant (such that where the Applicant is the sole office holder, the First and Second Respondents be appointed jointly in his place; where the Applicant is joint office holder with the First Respondent, he be replaced by the Second Respondent; where the Applicant is joint office holder with the Second Respondent, he be replaced by the First Respondent) such that they be joint Administrators in respect of all of the aforementioned Administration proceedings;
- 6. In relation to all of the Company Liquidation proceedings set out in Schedules E and F hereto, the First and Second Respondents be appointed in place of the Applicant (such that where the Applicant is the sole office holder, the First and Second Respondents be appointed jointly in his place; where the Applicant is joint office holder with the First Respondent, he be replaced by the Second Respondent; where the Applicant is joint office holder with the Second Respondent, he be replaced by the First Respondent) such that they be joint Liquidators in respect of all of the aforementioned Company Liquidation proceedings;
- 7. In relation to the Company Liquidation proceedings set out in Schedule G hereto, the Second Respondent be appointed joint Liquidator in place of the Applicant, such that the Second and Third Respondents be joint Liquidators in respect of all of the aforementioned Company Liquidation proceedings;
- 8. The Respondents (or any of them) do procure that as soon as reasonably practicable, and in any event within 3 months from the date of this Order, a block advertisement in relation to each of the Insolvency Proceedings listed in the

attached Schedules be placed in the London Gazette containing notification of the following matters:

- a. the appointment of the First and Second Respondents as office-holders in respect of the insolvency proceedings listed in Schedules A to G attached; and
- b. the fact that the creditors or (in the case of individual voluntary arrangements or bankruptcies) debtor in the Insolvency Proceedings set out in the Schedules hereto have liberty to apply, within 28 days after publication of the aforementioned block advertisement, to vary or discharge the Order made.
- 9. The Respondents do procure that within 6 months from the date of this Order, a report is made to creditors in relation to each of the Insolvency Proceedings listed in the attached Schedules in respect of which they are appointed, containing notification of the following matters:
  - a. the appointment of the First and Second Respondents as office-holders; and
  - b. the fact that the creditors or (in the case of individual voluntary arrangements or bankruptcies) debtors have liberty to apply, within 28 days after the date of the report, to vary or discharge the Order made.
- 10. There be liberty to each creditor or (in the case of individual voluntary arrangements or bankruptcies) debtor in the Insolvency Proceedings set out in the Schedules hereto to apply to vary or discharge this Order insofar as it relates to the Insolvency Proceedings in relation to which that person is a creditor or debtor, within 28 days after publication of the block advertisement pursuant to paragraph 8 above or within 28 days after the reports are made pursuant to paragraph 9 above (in any event, the period of 28 days running from the later event);
- 11. The Applicant's costs of this Application be apportioned equally between the Insolvency Proceedings set out in the Schedules hereto and be paid as an expense thereof.
