NOTES TO THE FINANCIAL STATEMENTS

1. DIRECTORS' ADVANCES, CREDITS AND GUARANTEES

At the beginning of the year the directors loan account was was a credit balance of £27,511. During the year the director withdrew £35,902 and repaid company expenses of £25,297. As a result, at the end of the year the company owed £16,906 to the directors.

The company is entitled to exemption from audit under Section 477 of the Companies Act 2006 for the year ended 31 March 2014.

The members have not required the company to obtain an audit of its financial statements for the year ended 31 March 2014 in accordance with Section 476 of the Companies Act 2006.
