1. DIRECTORS' ADVANCES, CREDITS AND GUARANTEES

At the beginning of the year the directors loan account had a credit balance of £16,906. During the year the director withdrew £6,080 and repaid £17,138. As a result, at the end of the year the company owed £27,964 to the directors.

The company is entitled to exemption from audit under Section 477 of the Companies Act 2006 for the year ended 31 March 2015.

The members have not required the company to obtain an audit of its financial statements for the year ended 31 March 2015 in accordance with Section 476 of the Companies Act 2006.
