ORDER

UPON THE APPLICATION of Brett Barton of Cranfield Business Recovery Limited, Business Innovation Centre, Harry Weston Road, Coventry, CV3 2TX ("the Applicant")

UPON HEARING Counsel for the Applicant and [Counsel for the Respondent/Solicitor for the Respondent/Respondent appearing in person/the Respondent not being present]

AND UPON READING the Witness Statements of Brett Barton, Tony Mitchell and Nedim Ailyan

IT IS ORDERED THAT

1. Each of the County Court and District Registry cases listed in Schedules A, B, C, D, E, F and G (attached to this order) be transferred to the High Court of Justice, Chancery Division, Companies Court for the purpose only of making this order.
2. Immediately upon this order taking effect, the County Court and District Registry cases listed in Schedules A, B, C, D, E, F and G (attached to this order) be transferred back to the relevant County Court.
3. The Applicant (the "**outgoing officeholder**") be removed from office in respect of each of the cases listed in Schedules A, B, C, D, E, F and G (attached to this order) (the "**block transfer cases**") from the date of this order.
4. The First Respondent (the "**replacement officeholder**") be appointed as replacement officeholder for the outgoing officeholder in respect of each of the block transfer cases listed in Schedules E, F and G from the date of this order and shall remain in office as sole insolvency officeholder in respect of each of the cases listed in Schedules A, B, C and D.
5. The creditors in each of the block transfer cases listed in Schedules A, B, C, D, E, F and G be notified of this order by advertisement published in the London Gazette within 21 days of the order.
6. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies listed in Schedules A, B, C, D, E, F and G who has an objection to this order shall have 21 days from the date of the advertisement referred to in paragraph 5 to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases listed in Schedules A, B, C, D, E, F and G until further or other order by the court.
7. The replacement officeholder shall give notice to the Secretary of State and the Registrar of Companies (if applicable) in respect the cases listed in Schedules A, B, C, D, E, F, and G of the terms of this order as soon as reasonably practicable.
8. The outgoing officeholder shall file a copy of this order with each of the courts listed in Schedules A, B, C, D, E, F and G.
9. Nothing in this order shall release the outgoing officeholder from any obligation to give and file notices in respect of his removal under this order in respect of the block transfer cases listed in Schedules A, B, C, D, E, F and G.

10. The outgoing officeholder shall receive his release as office holder 21 days after giving notice to creditors in accordance with paragraph 5 above this save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 6 of this order for the specific case subject to that application.
11. Nothing in this Order requires the time for production of any progress reports in respect of the estates listed in schedules A, B, C, D, E, F and G.
12. Service of the Application be permitted by email (deemed served immediately upon sending), and the time for service be abridged so that the Application may be determined immediately upon filing at Court.
13. No order as to costs.
