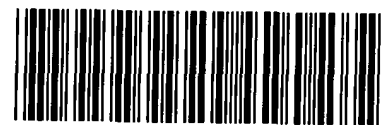

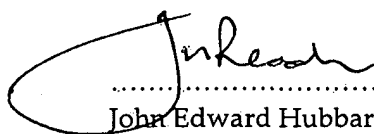

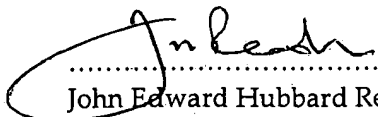
For the period ended 31 December 2021 the company was entitled to exemption under section 480 of the Companies Act 2006 ("Act") relating to dormant companies.
