Notes to the Financial Statements

1 Accounting policies

Howglen Care Services Ltd. (the "Company") is a private company incorporated, domiciled and registered in the UK. The registered number is 04719127 and the registered address is Libra House, Sunrise Parkway, Linford Wood, Milton Keynes MK14 6PH. The company has not traded during the year or the preceding financial period.

1.1 Basis of preparation

The financial statements have been prepared under the historical cost accounting rules and in accordance with Financial Reporting Standard 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland ("FRS 102") as issued in August 2015. The presentation currency of these financial statements is sterling. All amounts in the financial statements have been rounded to the nearest £1.

In transition to FRS 102 from old UK GAAP, the Company has taken advantage of the exemptions available under FRS 102 to dormant companies. The accounting policies set out below have, unless otherwise stated, been applied consistently to all periods presented in these financial statements. On first time adoption of FRS 102, the company has not retrospectively changed its accounting under old UK GAAP.
