

ORDER

UPON READING the Application dated 1 July 2021 pursuant to Chapter 6 (Sub-division B) of Part 12 of the Insolvency (England and Wales) Rules 2016 (SI 2016/1024).

AND UPON READING the Witness Statements of Dean Watson dated 1 July 2021 and the Consents to Act of the Applicants contained in the exhibits marked "DW1" "DW2" "DW3" "DW4" and "DW5" of the statement of Dean Watson

IT IS ORDERED that:-

1. In respect of those Creditors' Voluntary Liquidations, Administrations, Compulsory Liquidations, Members' Voluntary Liquidations and Bankruptcies listed in the Schedules to this Application which are the subject of proceedings in the County Court, those proceedings be transferred to the High Court solely for the purpose of this Application and thereafter transferred back to the relevant County Court.
2. The First Respondent be removed from office as office holder of the companies and bankruptcy estates (as the case may be) over which he is referred to as the current appointee in the attached schedules ("**the Block Transfer Cases**") without being required to (i) use one of the decision procedures or deemed consent procedures set out in the Rules for the insolvency cases listed in the Schedule, (ii) apply to the Secretary of State for release or discharge pursuant to the Insolvency Act 1986 or (iii) file a receipts and payments account.
3. The First Respondent be replaced as office holder of the cases referred to in paragraph 2 above by the Applicants in accordance with the terms of the attached schedules, without being required to (i) use one of the decision procedures or deemed consent procedures set out in the Rules for the insolvency cases listed in the Schedule (ii) apply to the Secretary of State for release or discharge pursuant to the Insolvency Act 1986 or (iii) file a receipts and payments account.
4. In the cases where the First Respondent is being replaced in the office of Administrator, the Applicants replacing them in each case shall additionally replace them as the nominated liquidators where and to the extent that the First Respondent is referred to as the nominated liquidator for any future liquidation in the Administrators' proposals which have been approved by the creditors.
5. The removal and appointments granted by this Order shall not disturb the existing reporting cycle for each of the respective Block Transfer Cases and the current time limit for reporting to creditors on each of the insolvency appointments shall continue irrespective of the removal and appointments made by this Order.
6. The First Respondent be granted his release as office holder of the cases referred to in paragraph 2 of this order 21 days after the publication in the London Gazette referred to below.
7. The Applicants be entitled to publish in the London Gazette one composite notice relating to all new appointments which are required by law to be published in the Gazette within 14 days of receipt of the sealed Order and shall file any appropriate notices in respect of the removal of the First Respondent, the appointment of replacement office holders, and those appointments with the Registrar of Companies and the Secretary of State for Business Innovation and Skills (Insolvency Services) as appropriate.
8. The creditors in each of the Block Transfer Cases be notified of this order by one composite advertisement published in the London Gazette per paragraph 7 of this Order.
9. The cost of placing notice of this Order in the London Gazette (but not the costs of this Application) be aggregated and be drawn as a proper expense of the Block Transfer Cases which shall bear an equal proportion of such costs and disbursements where sufficient funds are available.
10. If in any of the Block Transfer Cases there are insufficient funds to bear that case's ostensible share of the cost of placing the Notice in the London Gazette, the Applicants may apportion that case's share of the cost among the other cases listed in the Schedules at their discretion.
11. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies or persons listed in the schedules who has an objection to this order shall have 21 days from the date of the advertisement to apply to court to set aside or vary

the terms of this order. Such application shall not affect the transfer of the Block Transfer Cases until further or other order by the court.

12. In the case of the Administrations listed in the appended schedules, the First Respondent be released forthwith from any and all liability past, present or future in respect of any act(s) and/or omissions in relation to his conduct as Outgoing Officeholder of the estates. Such release to take effect 28 days from the date of the advertisement in paragraph 7 of this order, save in respect of any claim notified to the Applicants pursuant to the Insolvency Act 1986 and/pursuant to such other provision as may apply on or prior to the notice date.
13. The Applicants shall give notice to the Secretary of State (Insolvency Service) of the terms of this Order as soon as reasonably practicable.
14. Nothing in this Order shall release the First Respondent from any obligation to give and file notices in respect of his removal under this Order in respect of the Block Transfer Cases.
15. The First Respondent shall receive his release as Liquidator, Supervisor or Administrator (as appropriate) 28 days after giving of notice to creditors in accordance with this Order in accordance with paragraph 7, save that such release may be subject to further Order in the event of an application by any creditor or member under paragraph 11 of this Order for the specific case subject to that application.
16. Where there are joint office holders appointed on the Block Transfer Cases, they will act jointly and severally in relation to all matters relating to the administration of the Block Transfer Cases.
17. The terms of the order shall not apply to any case which is listed in the Block Transfer Cases. but which, prior to the order being made, is concluded and the case closed.
18. The costs of the Application be an expense of the insolvency proceedings of the Block Transfer Cases and be apportioned rateably, provided that the costs payable pursuant to the Application in relation to any of the Block Transfer Cases shall not exceed 10% of the value of the perceived assets in that particular insolvency proceeding;
19. Service of Notice of the Application be dispensed with.
20. Such further order or other relief or direction as the court shall deem fit.
