#### REPORT OF THE DIRECTORS

For The Year Ended 30 September 2012

The directors present their annual report and the audited financial statements for the year ended 30 September 2012. The Report of the Directors has been prepared in accordance with the special provisions applicable to the companies subject to the Small Companies Regime of the Companies Act 2006.

### PRINCIPAL ACTIVITY

The principal activity of the company is that of a holding company. The company owns 18 23% of the ordinary share capital of Bruntwood Group Limited

The results for the year are set out in detail on page 5 The company made a profit after taxation of £1 7m (2011 - £2 8m) Profit continues to be generated from dividends received from Bruntwood Group Limited Bruntwood Group Limited continues to make sufficient profit to meet the dividend requirements of the company

During the year preference dividends of £1 7m were paid (2011 - £2 8m) and no ordinary dividend was paid (2011 - £nil)

#### GOING CONCERN

After making enquiries, the directors believe that the company has adequate resources to continue in operational existence for the foreseeable future. Accordingly, they continue to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in note 1 of the financial statements.

### FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The company considers its principal risks to be the financial performance of Bruntwood Group Limited and its ability to pay dividends to enable the company to meet its preference share dividend obligations. This risk is managed through regular shareholder contact with the Bruntwood Limited executive team and a quarterly shareholder board meeting to review its performance.
