1 Executive summary

The Company originally entered administration on 21 May 2019 and William James Wright and Mark Jeremy Orton were appointed as Joint Administrators.

In the process of applying to Court for an extension to the period of the administration for twelve months to 20 May 2022, the Joint Administrators discovered that there had been an oversight regarding the process for obtaining the consent of the preferential creditors for the first extension to the period of the administration in May 2020. After obtaining legal advice, an application was made to the Court by William James Wright and Mark Jeremy Orton, as creditors of the Company, and Will James Wright and Mark Jeremy Orton were retrospectively appointed as Joint Administrators by the Court, together with approval for an additional 12-month extension to 20 May 2022. A copy of the sealed Order was made available to view on the Portal. (Section 2 - Background and events leading to the administration).

This document, together with its appendices, forms the Joint Administrators' statement of proposals to creditors for the retrospective administration order in accordance with Paragraph 49 of Schedule B1 to the Insolvency Act 1986 and the Insolvency Rules. The proposals are deemed delivered four business days after they are dated.

This document should be read in conjunction with the Joint Administrators' statement of proposals dated 18 July 2019 (the "First Proposals") and subsequent progress reports issued to creditors. Copies of all previous reports are available upon request in hard copy or from the insolvency portal.

The Secured creditors will likely suffer a significant shortfall in respect of the funding provided to the Company and the wider Group (Section 4 - Dividend prospects).

We anticipate that the preferential creditors will be paid in full (Section 4 - Dividend prospects).

Based on current estimates, we anticipate that a distribution will be made to the unsecured creditors, however we are not yet able to confirm the quantum or timing (Section 4 - Dividend prospects).

We intend to seek approval of these proposals by deemed approval (Section 6 – Approval of proposals).

We propose that our remuneration will be drawn on the basis of time properly given by us and the various grades of our staff in accordance with the fees estimate and charge out rates provided. We will seek approval of our remuneration from the Secured and preferential creditors by a separate decision procedure (Section 7 - Joint Administrators' remuneration and expenses).

On completion of the administration, we anticipate that the most likely exit route will be dissolution (Section 5 - Ending the administration).

This document in its entirety is our statement of proposals. A summary list of the proposals is shown in Section 8 together with all relevant statutory information included by way of appendices. Unless stated otherwise, all amounts in the proposals and appendices are stated net of VAT.

2 Background and events leading to the administration

2.1 Background information

The Company was incorporated on 27 June 2003 and operated as a restauranteur with 20 restaurants at various locations across the UK and three sites at Gatwick airport (restaurant and deli at North Terminal and a restaurant at South Terminal). The Company was the main trading entity within the Jamie Oliver Restaurant Group.

Full details regarding the Company's financial position, funding and the events leading to the initial administration are set out in full in the First Proposals first issued in July 2019 which are available on the Portal. The First Proposals also contain the statement of affairs prepared as at 21 May 2019 being the date the Company first entered administration. The current financial position of the Company is available to view at Appendix 2 of these Proposals.

2.2 Events leading to the administration

It was brought to our attention that the process for obtaining the consent of the preferential creditors for the first extension did not comply with the strict interpretation of the Insolvency Rules 1986 (as amended). Accordingly, we made an application to Court for a retrospective administration order to cover the period 21 May 2020 to 20 May 2021. A further extension has also been granted by the Court to 20 May 2022 to allow sufficient time to conclude matters in the administration.

2.3 Appointment of Joint Administrators

The initial appointment of William James Wright and Mark Jeremy Orton took place on 21 May 2019. The appointment was made by the Directors of the Company and a first extension via a deemed consent procedure was sought in March 2020. Following the events detailed in Section 2.2 above, Court applications were recently made by William Wright and Mark Orton, as creditors of the Company in respect of their unpaid outstanding remuneration of £1,122,436, under paragraph 12(1)(c) of Schedule B1 of the Act.

The Court applications were made to seek the following orders:

- That the Company be retrospectively placed into administration with effect from 00.01 on 21 May 2020;
- That Mark Jeremy Orton and William James Wright be retrospectively appointment Joint Administrators; and
- That the Administration be extended until 23.59 on 20 May 2022 pursuant to paragraph 76(2)(a) of Schedule B1 of the Insolvency Act 1986.

The Court applications were heard in Court on 20 May 2021 and the Orders were made. The Orders can be viewed on the Portal.

Both Joint Administrators are licenced Insolvency Practitioners by the Institute of Chartered Accountants in England and Wales.

3 Strategy and progress of the administration to date

3.1 Strategy to date

Strategy

Following approval of the Joint Administrators' proposals, we will continue to conduct the Administration to achieve the purpose of the administration.

Key matters to be undertaken include:

- finalising payment of the costs of the administration, including our remuneration and expenses;
- agreeing preferential and unsecured creditors' claims and paying distributions to both classes of creditor;
- submitting final VAT and tax returns, including obtaining tax clearance; and
- concluding statutory and compliance matters to bring the administration to a close.

3.2 Asset realisations

Realisations from the date of our appointment to 1 June 2021 are set out in the attached receipts and payments account (Appendix 2).

3.3 Costs

An estimate of all the anticipated costs likely to be incurred throughout the duration of the administration is set out in the attached summary of expenses (Appendix 4).

Payments made from the date of our appointment to 1 June 2021 are set out in the attached receipts and payments account (Appendix 2).

4 Dividend prospects

4.1 Secured creditors

At the time of our appointment, there were two secured creditors of the Group, namely JOHL and HSBC. The detail regarding the secured debts is covered in full in the first set of Proposals issued in July 2019 which are available on the Portal.

As previously advised, the first £5.45 million of net returns from the Administration of the Company (and the other guarantors) would be due to JOHL as Secured creditor. It is anticipated that net returns will result in a significant shortfall to this figure.

We instructed our legal advisor during the original appointment to carry out a review of the securities held by the Secured creditors. Our solicitors confirmed the charges are valid.

In addition, during the original administration appointment, we made a floating charge distribution of £1.75 million to JOHL.

4.2 Preferential creditors

Claims from employees in respect of (1) unlimited accrued holiday pay and (2) certain pension benefits, rank preferentially.

We estimate the amount of preferential claims at the date of our appointment as at 21 May 2020 to be £371,000.

Based on current estimates, preferential creditors should receive a dividend of 100p in the £. We are currently reviewing creditor claims and we will shortly be in a position to make a distribution to preferential creditors.

4.3 Unsecured creditors

Based on current estimates, we anticipate that unsecured creditors should receive a dividend. We have yet to determine the exact amount of this, but we will do so when we have completed the distribution to the preferential creditors and the payment of associated costs. We expect to invite final claims from unsecured creditors in the next 8 weeks.

5 Ending the administration

5.1 Exit route from administration

We consider it prudent to retain all of the options available to us, as listed in Section 8 to bring the administration to a conclusion in due course.

However, at this stage we anticipate that the most likely exit route will be dissolution.

5.2 Discharge from liability

We propose to seek approval from the Secured and preferential creditors that we will be discharged from liability in respect of any action as Joint Administrators upon the filing of our final receipts and payments account with the Registrar of Companies.

Discharge does not prevent the exercise of the Court's power in relation to any misfeasance action against us.

Should the circumstances of the administration change, we reserve the right to revert to the unsecured creditors in order to obtain discharge from liability.

6 Approval of proposals

6.1 Deemed approval of proposals

The administrators' proposals will be deemed approved, with no requirement to seek deemed consent or use a decision procedure, as it appears that the Company has insufficient property to enable us to make a distribution to the unsecured creditors other than by virtue of the Prescribed Part, as detailed in Appendix 1.

On expiry of eight business days from the date our proposals were delivered to the creditors, they will be deemed to have been approved by the creditors unless 10% in value of creditors request that a decision procedure is convened. Further details of the steps to convene a procedure are detailed below.

6.2 Creditors' right to request a decision

We will use a decision making procedure or deemed consent to seek approval of our proposals (1) if asked to do so by creditors whose debts amount to at least 10% of the total debts of the Company, and (2) if the procedures set out below are followed.

Requests for a decision must be made within eight business days of the date on which our proposals were delivered. They must include:

- a statement of the requesting creditor claim;
- a list of the creditors concurring with the request, showing the amounts of their respective debts in the administration;
- written confirmation of their concurrence from each concurring creditor; and
- a statement of the purpose of the proposed meeting;

In addition, the expenses of the decision procedure at the request of a creditor must be paid by that creditor. That creditor is required to deposit security for such expenses with us.

If you wish to request a decision, please complete and return the decision requisition form available on the Portal.

7 Joint Administrators' remuneration and expenses

7.1 Approval of the basis of remuneration and expenses

We propose to seek approval from the Secured and preferential creditors that:

our remuneration will be drawn on the basis of time properly given by us and the various grades of our staff in accordance with the fees estimate provided in Appendix 3 and the charge-out rates included in Appendix 5;

Category 2 expenses (as defined in Statement of Insolvency Practice 9) will be charged and drawn in accordance with Interpath Advisory's policy as set out in Appendix 5.

Agreement to the basis of our remuneration and the drawing of Category 2 expenses is subject to specific approval. It is not part of our proposals.

Should the circumstances of the administration change, we reserve the right to revert to the unsecured creditors in order to seek approval for the basis of remuneration and the drawing of Category 2 expenses.

Time costs

From the date of our retrospective appointment to 1 June 2021, we have incurred time costs of £79,973. These represent 189 hours at an average rate of £424 per hour.

Expenses

We have incurred expenses of £6 during the period. None of these have yet been paid.

Additional information

We have attached (Appendix 5) an analysis of the time spent, the charge-out rates for each grade of staff and the expenses paid directly by Interpath for the period from our appointment to 1 June 2021. We have also attached our charging and expenses recovery policy.

The time costs incurred during the previous administration were detailed in the Former Administrators' progress reports dated 18 December 2019, 28 May 2020 and 9 December 2020. The previous administration had automatically ended on 20 May 2020, although the Company's affairs were conducted as though the administration was in place, until the Court Order was made on 20 May 2021, retrospectively making a new administration appointment on 21 May 2020.

The prior administration time costs detailed above represent outstanding time costs for the period prior to 20 May 2020.

The payment of these unpaid costs as an expense of the administration is subject to approval in accordance with rule 3.52 of the Insolvency Rules and is not part of the proposals subject to approval in accordance with Paragraph 53(a) of Schedule B1 of the Insolvency Act 1986.

We have agreed with JOHL that our fees will be capped at a level to be agreed once all matters in the administration are complete. We will not be recovering our time costs in full.

8 Summary of proposals

In accordance with our First Proposals issued in July 2019, we believe that rescuing the Company in accordance with Paragraph 3(1)(a) is not achievable.

Therefore our primary objective continues to be to achieve a better result for the Company's creditors as a whole than would be likely if the Company were wound up, in accordance with Paragraph 3(1)(b).

In addition to the specific itemised proposals below, this document in its entirety constitutes our proposals.

We propose the following:

General matters

to continue to do everything that is reasonable, and to use all our powers appropriately, in order to maximise realisations from the assets of the Company in accordance with the objective as set out above;

to investigate and, if appropriate, to pursue any claims the Company may have; to seek an extension to the administration period if we consider it necessary.

Distributions

to make distributions to the secured and preferential creditors where funds allow; to make distributions to the unsecured creditors if funds remain available, and to apply to the Court for authority to do so, where applicable.

Ending the administration

We might use any or a combination of the following exit route strategies in order to bring the administration to an end:

apply to Court for the administration order to cease to have effect from a specified time and for control of the Company to be returned to the Directors;

formulate a proposal for either a company voluntary arrangement (CVA) or a scheme of arrangement and put it to meetings of the Company's creditors, shareholders or the Court for approval as appropriate;

place the Company into creditors' voluntary liquidation. In these circumstances we propose that we, Will Wright and Steve Absolom, be appointed as Joint Liquidators of the Company without any further recourse to creditors. If appointed Joint Liquidators, any action required or authorised under any enactment to be taken by us may be taken by us individually or together. The creditors may nominate different persons as the proposed Joint Liquidators, provided the nomination is received before these proposals are approved;

petition the Court for a winding-up order placing the Company into compulsory liquidation and to consider, if deemed appropriate, appointing Will Wright and Steve Absolom as Joint Liquidators of the Company without further recourse to creditors. Any action required or authorised under any enactment to be taken by us as Joint Liquidators may be taken by us individually or together;

file notice of move from administration to dissolution with the Registrar of Companies if we consider that liquidation is not appropriate because (1) no dividend will become available to creditors, and (2) there are no other outstanding matters that require to be dealt with in liquidation. The Company will be dissolved three months after the registering of the notice with the Registrar of Companies.

Alternatively, we may allow the administration to end automatically.

Joint Administrators' remuneration and pre-administration costs

We propose that:

our remuneration will be drawn on the basis of time properly given by us and the various grades of our staff in accordance with the fees estimate provided in Appendix 3 and the charge-out rates included in Appendix 5.;

Category 2 expenses (as defined in Statement of Insolvency Practice 9) will be charged and drawn in accordance with Interpath Advisory's policy as set out in Appendix 5; unpaid prior administration costs be an expense of the administration.

Discharge from liability

We propose that we shall be discharged from liability in respect of any action of ours as Joint Administrators upon the filing of our final receipts and payments account with the Registrar of Companies.

Policy for the recovery of expenses

Where funds permit the officeholders will seek to recover both Category 1 and Category 2 expenses from the estate. For the avoidance of doubt, such expenses are defined within SIP 9 as follows:
