- The cases listed in Schedules A to E attached to this Order, in so far as there are currently proceedings in the County Court or in a District Registry be transferred to the High Court in London for the purpose of making the Orders listed below
- Stephen John Hunt of Griffins, Tavistock House South, Tavistock Square, London, WC1H 9LG and Amanda Wade of Grant Thornton UK LLP, 30 Finsbury Square, London, EC2P 2YU (the "Successor Practitioners") be appointed as the Trustees in bankruptcy of each of the individuals listed in Schedule A to this Order (such appointment to be joint and several) with immediate effect, Mrs Francis having automatically vacated office pursuant to Section 298(6) of the Insolvency Act 1986
- Mrs Francis be and is hereby removed as the Supervisor of each of the company voluntary arrangements listed in Schedule B to this Order and replaced by the Successor Practitioners (such appointment to be joint and several) with immediate effect
- The Successor Practitioners be appointed as the Liquidators of each of the companies listed in Schedule C to this Order (such appointment to be joint and several) with immediate effect, Mrs Francis having automatically vacated office pursuant to Section 171(4) of the Insolvency Act 1986
- 5. Mrs Francis be and is hereby removed as the Supervisor of each of the individual voluntary arrangements listed in Schedule D to this Order and replaced by the Successor Practitioners (such appointment to be joint and several) with immediate effect
- 6 In relation to the appointments listed at Schedule E to this Order
 - Mrs Francis be and is hereby removed as the Joint Supervisor of each of the individual voluntary arrangements listed at rows 1 to 3 and replaced by the Successor Practitioners with immediate effect such appointment to be held jointly and severally with Mr Bland, and
 - Mrs Francis having automatically vacated office as the Joint Liquidator of the company listed at row 4 of Schedule E to this Order pursuant to Section 171(4) of the Insolvency Act 1986, the Successor Practitioners be appointed as Liquidators of the company listed at row 4 of Schedule E to this Order with immediate effect such appointment to be held jointly and severally with Mr Bland.
- 7 Mrs Francis be prohibited from withdrawing any monies whatsoever, whether in respect of outstanding remuneration or otherwise, from the estates of the transferred cases identified in Schedules A to E (inclusive) to this Order without the permission of the Court or the written consent of the Successor Practitioners

- Mrs Francis shall within 14 days of the date of this Order serve and file a witness statement setting out details of all insolvency appointments held by her in the 24 months preceding the date of this Order stating the name of the individual or company over which she was appointed, the date of her appointment, the office or offices held by her in respect of each individual or company and the date on which Mrs Francis ceased to hold office
- 11 Rules 4 49C(3)(a) and 6 78A(4) of the Insolvency Rules 1986 shall not apply as a consequence of this Order
- The Successor Practitioners shall give notice of their appointments to all creditors of the estates listed in Schedules A and C and Row 4 of Schedule E (inclusive) to this Order within 28 days of the date of this Order by way of advertisement in the London Gazette
- The Successor Practitioners shall give notice of their appointments to all creditors of the estates listed in Schedules B and D and Rows 1 to 3 of Schedule E (inclusive) by first class post within 28 days of the date of this Order
- All creditors of the estates listed in Schedules A and C and Row 4 of Schedule E to this Order do have permission to apply to the Court, on Notice to the Applicant and the Successor Practitioners, within 28 days of the advertisement referred to in paragraph 12 above for the purpose of applying to vary or discharge the Order insofar as it affects the estate or estates of which they are a creditor
