1 ACCOUNTING POLICIES

The financial statements are prepared in accordance with applicable United Kingdom accounting standards. The particular accounting policies adopted are described below.

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2007).

The financial statements are prepared under the historical cost convention.

Tangible fixed assets

Tangible fixed assets are stated at cost, less depreciation and any provision for impairment. Depreciation is provided on cost in equal annual instalments to write down the assets to their residual values over their estimated useful lives. The rates of depreciation are as follows:

Furnishings, fittings and fixtures	-	33% of cost per annum
Shop equipment	-	33% of cost per annum
