ORDER

UPON the application of Robert William Leslie Horton dated November 2018 ("the Application")

AND UPON reading the evidence

AND UPON the Secretary of State having been duly served with a copy of the Application and supporting documentation

AND UPON the Respondent consenting to the Application

AND UPON the Court being satisfied that it is entitled to determine the Application without a hearing pursuant to Rules 12.12(1)(c) and 12.38(1) of the Insolvency Rules 2016

IT IS ORDERED THAT:-

1. Pursuant to Rule 12.30 of the Insolvency Rules 2016 ("the Rules") any of the matters listed in the Schedule to this Order ("the Schedule") which are proceeding in any court other than the High Court are transferred to the High Court solely for the purposes of this Order and immediately upon this order taking effect are immediately transferred back to the court listed in the Schedule.

2. Pursuant to Rule 12.37(2) of the Rules, the Respondent be removed from his office as liquidator, administrator, supervisor or trustee in bankruptcy of the matters listed in the Schedule with immediate effect.
3. The Applicant shall file a copy of this Order with each of the Courts listed in the Schedule and shall file any appropriate notices in respect of the Respondent's removal with the Registrar of Companies and the Secretary of State for Business Energy Innovation and Skills (Insolvency Service) as appropriate and as soon as practicable.
4. Where required any relevant notice required to be filed at Court be filed at the same time as the next notification as required pursuant to statute.
5. The effect of this order shall be notified to the creditors or members, as appropriate, at the same time as the next report pursuant to statute is made to the creditors or members. Such notice shall include an explanation as to the effect of the Order and express reference to the liberty to apply as set out in the Order.
6. Liberty to each creditor of each bankruptcy and liquidation and, in the case of members' voluntary liquidation, any member of any company, to apply to vary or discharge the Order within 28 days of receipt of the notice referred to in paragraph 6 of this Order.
7. The Respondent outgoing officeholder shall receive his release as administrator, liquidator, supervisor and trustee 28 days after filing notice of his removal with the Registrar of Companies, where applicable, or the giving of notice to creditors in accordance with this Order in any other case, save that such release may be subject to further order in the event of an application by any member or creditor under paragraph 7 of this Order for the specific case subject to that application.
8. Such other order as the court sees fit.
