1. General information

Cable Construction Limited is a private company limited by shares, incorporated in England and Wales (registered number: 04912402). Its registered office is Unit 15 Neepsend Triangle Business Centre, 1 Burton Road, Sheffield, South Yorkshire, S3 8BW. The principal activity of the Company during the year was that of a dormant company.

2. Accounting policies
