

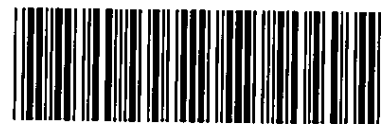

NOTES TO THE ACCOUNTS FOR THE YEAR

ENDED 31ST OCTOBER 2008

1. ACCOUNTING POLICIES

The principal Accounting policies adopted in the preparation of the Financial Statements are set out below and have remained unchanged from the previous year, and also have been consistently applied within the same accounts.

(a) BASIS OF PREPARATION OF FINANCIAL STATEMENTS

The Financial Statements have been prepared under historical cost convention.

The effect of the events relating to the year ended 31st October 2008 which occurred before the Date of approval of the Financial Statements by the Board Of Director, have been included in the Statements to the extent required to show a true and fair view of state of affairs and of the results for the year ended on that date.

The company has taken advantage of the exemption in FRS 1 from the requirement to prepare a cash flow statement on the grounds that this is a Small Company.

(b) TURNOVER

The company's turnover represents the value, excluding value-added tax, of goods and services supplies to customers during the year.

(c) DEPRECIATION

Depreciation is provided on all fixed assets at rates calculated to write off the cost. Less estimated residual value of each asset over it's expected useful life at the following annual rates.

(d) Stocks And Work In Progress

Stocks and work in progress have been valued at the lower of cost and net realisable value. Cost is based on the cost of purchases on the first in, first out basis.

(e) Deferred Taxation

Deferred Taxation is provided on the liability method to take account of timing differences between the treatment of certain items for account purposes and their treatment for tax purposes. Tax Deferred or accelerated is accounted for in respect of all timing differences to the extent that it is considered that a net liability may crystallise.
