1. ACCOUNTING POLICIES

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Small Entities (effective April 2008).

Financial reporting standard number 1

Turnover

Turnover represents net invoices sales of services excluding value added tax. Turnover is recognised when the work has been completed, but there was no work in the year ended 31 March 2013.
