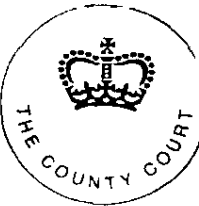
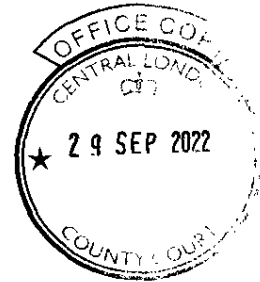

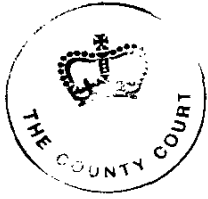

IT IS ORDERED that:

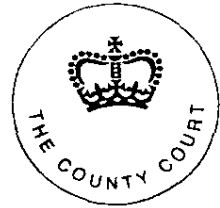
- (1) the name of the above named Tony Griffiths Scaffolding Pontypridd Limited be restored to the Register of Companies
