Reporting Accountants


Poulton Accounting Services Ltd have indicated their willingness to remain in office and a resolution proposing re-approval was put to the Annual General Meeting for approval.

PURSUANT TO PARAGRAPH 24 OF SCHEDULE 8 TO THE COMPANIES ACT 1985

We have examined the abbreviated financial statements on pages 4 to 6, together with the full financial statements of JPD Training Consultants Limited for the year ended 30th November 2007. 



(a) **Accounting Convention:**

The Accounts have been prepared under the historical cost convention

(b) **Depreciation:**

Depreciation is provided at appropriate rates of write-off for the cost of fixed assets over their estimated useful lives. The rate of 25% on a reducing balance basis for Plant/Machinery and Office Equipment, being in line with Inland Revenue Rates or 50% as appropriate for first year depreciation on Plant/Machinery and Computer Equipment

Expenditure on Research and Development is written off in the year in which it is incurred
