#### **Receipts and Payments Account**

#### Asset Realisation

The statement of affairs show assets estimated to realise £46,934 as at the date of liquidation. The assets have realised £19,500 exclusive of VAT

The statement of affairs shows estimate of unsecured claims of £132,000 and claims received to date total some £180,000

#### Distribution

There are no surplus funds with which to make a distribution to any class of creditor

#### Liquidator's Remuneration

The Liquidator's remuneration was approved on a time cost basis at the meeting of the creditors on the 15 May 2012 and agreed at £5,000 plus VAT

The Liquidator has accepted an amount of £3,600 plus VAT as insufficient funds have been realised to cover the full fees due
