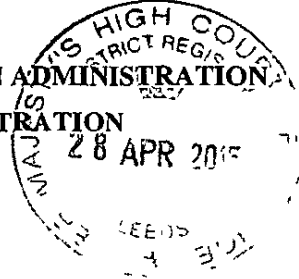

IT IS ORDERED that:-

1. Pursuant to Rule 7.10C (2) (b) and (c) the Respondent be removed from office in respect of each of the cases listed at Part A and Part B of Schedule 1 (which is attached to this Order) with effect from 28 April 2015,
 2. Pursuant to Rule 7 10C (3) (b) and (c), Howard Smith, ("the Replacement Office Holder") be appointed as replacement office holder in respect of each of the cases listed at Part B of Schedule 1 with effect from 28 April 2015.
 3. The Replacement Office Holder will act jointly and severally in relation to all matters relating to the administration of the cases listed in Part B of Schedule 1.
 4. The removal of the Respondent as outgoing office holder in respect of the cases listed at Part A and Part B of Schedule 1 and the appointments of the Replacement Office Holder in respect of the cases listed at Part B of Schedule 1 made by this Order shall take effect from 28 April 2015 without the requirement to hold a meeting of the creditors of each of the cases listed at Schedule 1.
 5. The creditors in each of the cases listed in Schedule 1 be notified of this Order by advertisement published in the London Gazette within 14 days of the making of this Order and at the time of the next statutory reporting required for each case
 6. Any creditor who has an objection to this Order shall be at liberty to apply to the Court within 21 days of the advertisement being published in the London Gazette
 7. No order as to costs
