REPORT OF THE DIRECTORS

The directors present their report, together with the audited financial statements for the period ended 31 December 2007

BUSINESS REVIEW AND PRINCIPAL ACTIVITIES

Rio Tinto Brazilian Holdings Limited ("the Company") is a wholly owned subsidiary of Rio Tinto plc ("Rio Tinto") The Company is an investment holding company for Rio Tinto Brasil Limitada and will continue to be so for the foreseeable future

The results of the Company for the year ended 31 December 2007 are set out on page 7

Details of the principal subsidiary undertaking at 31 December 2007 are given on page 12

The Company's profit for the financial year is \$249,422,000 (2006 \$153,170,000 loss). The Company does not produce consolidated financial statements as its results are consolidated into the financial statements of the Rio Tinto Group. The Company's results from year to year are highly sensitive to the timing of dividend flows and of movements in provisions, and do not necessarily reflect the performance of its group undertakings.

No interim dividend was paid during the year (2006 \$nil) The directors do not recommend the payment of a final dividend (2006 \$nil)

FUTURE DEVELOPMENTS

The Company's future developments are integrated with those of the Rio Tinto Group which are discussed in its 2007 Annual report and financial statements which do not form part of this report

PRINCIPAL RISKS AND UNCERTAINTIES

The company's principal risks and uncertainties are integrated with those of the Rio Tinto Group and are not managed separately. The Group's risk factors and policies for financial risk management are also discussed in its 2007 Annual report and financial statements which do not form part of this report.

We have audited the financial statements of Rio Tinto Brazilian Holdings Limited for the year ended 31 December 2007 which comprise the Profit and Loss Account, the Balance Sheet, and the related notes. These financial statements have been prepared under the accounting policies set out therein.

NOTES TO THE 2007 FINANCIAL STATEMENTS

1 ACCOUNTING POLICIES

a) Basis of Accounting

These financial statements are prepared on a going concern basis, under the historical cost convention and in accordance with the Companies Act 1985 and applicable UK accounting standards. The directors have reviewed the Company's existing accounting policies and consider that they are consistent with last year. The principal accounting policies are set out below.

b) Reporting Currency

The principal currency affecting Rio Tinto's international operations is the US dollar, and all financing provided to / by the Company is denominated in the US dollar Accordingly, the directors regard the US dollar as the principal currency affecting the Company's own cashflows. As a result, the financial statements are presented in US dollars. The year end exchange rate was US\$1.99 £1 (2006 \$1.96 £1).

c) Taxation

The Company does not pay for, or receive payment for, any group relief claimed from, or surrendered to, other Group companies

d) Deferred Taxation

Full provision is made for deferred taxation on all timing differences that have arisen but not reversed at the balance sheet date, except that deferred tax assets are only recognised to the extent that it is more likely than not that they will be recovered. Deferred tax is recognised on an undiscounted basis

e) Dividends

Final dividends are recognised when the obligation to make payment is established Interim dividends are recognised when paid

f) <u>Investments</u>

Fixed asset investments are valued at cost less impairment provisions Investments are reviewed for impairment if events or changes in circumstances indicate that the carrying amount may not be recoverable. When a review for impairment is conducted, the recoverable amount is assessed by reference to the net present value of expected future cash flows of the relevant income generating unit or disposal value if higher. The discount rate applied is based upon the Company's weighted average cost of capital, with appropriate adjustment for the risks associated with the relevant unit.

g) Group Financial Statements

Group financial statements have not been prepared as the Company is itself a wholly owned subsidiary of another company incorporated in England and Wales In the opinion of the directors, the aggregate value of the assets of the Company consisting of shares in, and amounts owing from, its subsidiary companies is not less than the aggregate amount at which those assets are included in the balance sheet

h) Currency Translation

Transactions denominated in foreign currencies are translated at the rate of exchange ruling on the date of the transaction

Monetary assets and liabilities expressed in foreign currencies are translated at the rates of exchange ruling at the end of the financial year Exchange differences, except where they relate to share capital, share premium and reserves, are dealt with in the profit and loss account

i) Reporting Format

The Company acts as an investment holding company, and hence the dividends received from investee companies and any impairment provisions against investments are presented as operating items

During the year the Directors have reassessed the carrying value of the company's investment in Rio Tinto Brasil Limitada, in light of the Groups plans for its mining projects which are pursued by that company. As part of the annual planning process the group has updated its net present valuation based on Rio Tinto Group's approved planning assumption. This exercise has indicated that the NPV of Rio Tinto Brasil Limitada is in excess of the historical cost investment in this activity and as such impairment provisions recognised in prior years of \$260,380,000 have been reversed in the 2007 profit and loss account.
