1 Statutory information

Interactive Voice Response Limited is a private company, limited by shares, registered in England and Wales, registration number 04988414. The registered office and principal place of business is 59 ST MARTIN'S LANE, LONDON, WC2N 4JS.

2 Compliance with accounting standards
