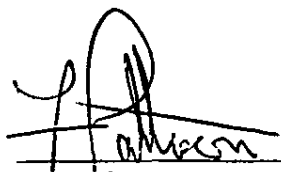

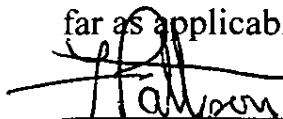

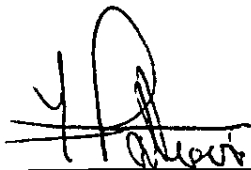
1. ACCOUNTING POLICIES
