REPORT OF THE DIRECTORS

FOR THE YEAR ENDED 31ST DECEMBER 2009

The directors present their report and the financial statements for the year ended 31st December 2009.

PRINCIPAL ACTIVITY

The principal activity of the company is to be a Christian Church and to provide Christian worship, teaching, prayer and group activities for its members, and outreach and events for the local community.

ADMINISTRATIVE INFORMATION

Charitable objectives

Brockley Community Church is governed by its Memorandum and Articles of Association The objects of the charity are:

- 1 To promote and advance the Christian Faith throughout the world generally including by the worship of God, the instruction and edification of Christians, the care and Christian instruction of young people and children and the evangelisation of non-Christians
- 2. To relieve poverty, hardship, sickness and distress among all peoples of the world.
- 3 To promote education and training.
- 4. To support such other charities and charitable purposes as the trustees shall decide.

Description of the organisation

Brockley Community Church is run by a Board of Directors who act as trustees of the charity and meet bi-monthly. Trustees are elected by church members for a period of three years. The trustees are responsible for the overall running of the charity and delegate certain responsibilities to a leadership team, led by the Church Leader Dr Andrew Parnham. The leadership team are responsible for the spiritual direction of the church, vision setting, the day to day running of the church and supporting and equipping church members.

RELATIONS WITH OTHER ORGANISATIONS

We are informally members of Transform Network, an association of congregations arising from relationships formed in Ichthus, members of I-Net, a missions organisation and of the Brockley ministers fraternal. We are also members of the Evangelical Alliance, Global Connections, Fusion and Voluntary Action Lewisham.

RISK MANAGEMENT

The trustees have continued to give consideration to the major risks faced by the company and continued with the process of introducing & reviewing policies, systems and procedures to mitigate those risks. In addition the trustees have ensured that they have appropriate public liability, employer's liability and property insurance.

FINANCIAL REVIEW

A high proportion of the church's income continues to come from the regular giving of its members through standing orders, "Give as You Earn", gifts via Stewardship, and Sunday morning offerings. The church has continued to emphasise the use of the gift aid system and giving by standing order, whilst recognising the different situations of its members. The majority of the giving was gift aided and the charity was able to recover over £10,000 in income tax paid. The budget for general giving for the year was £76,000. General giving was below this, at £70,341, but never the less was at a similar level to 2008, expenditure was slightly less than income, and reserves were maintained. The trustees have a Reserves Policy of having a general fund reserve of one month's (regular giving) income and the reserve has remained above this.

REVIEW OF THE YEAR - Andy Parnham, Church Leader

"So you're John's son, Simon? From now on you're going to be Peter - the Rock!!" (John 1:42)

One way of summing up 2009 would be with the phrase "Goodbyes and hellos" – we said goodbye to some very dearly loved and long-standing members of BCC, including Ray & Jenny Hall, Victoria, Alison Gill, and later in the year, Tim & Ruth. Well, the Bible does say it's better to give than receive! But there are other ways of looking at the year – for example, "Encountering, Living with, and Going with Jesus", which were the titles of our Sunday morning teaching programme throughout much of the year. It certainly felt like we were doing those things through 2009!

The year began with a farewell to Miranda Mora, who had done a great job as our church administrator for most of 2008. She was replaced by Liz Wood, for Miranda's 6 month maternity leave. In fact, Miranda was not to return, and there was more to develop later in the year, when in the summer, Liz's husband, Andy developed what turned out to be a rapidly growing turnour. He went to be with Jesus in the autumn

Later in January, we commissioned Alison Gill as *our missionary to Burundi*. She had spent many years preparing for this moment, so it was moving to pray her off. Being Alison, she has kept us well in touch over the following months. It's not been easy for her as a single woman in Burundi, but she has already made an impact there. George and Alison Burch also bade us farewell, as they teamed up again with Ichthus.

Our Sunday morning teaching through the early months of 2009 was entitled "A whole new life". Stuart and Marilyn Checkley and friends led us through material that normally forms part of the "Transformed Lives" course (aiming to help people find healing through Jesus in their personal lives and develop healthy habits in discipleship) The Checkleys were our guests at our weekend away in February at Letton Hall, Norfolk. We had been there a couple of years before, and although it poured with rain almost constantly that time, the welcome and facilities enticed us back again! We weren't disappointed, and everyone found the time uplifting and helpful We're there again later this year (Nov 2010).

Several of us fasted from something during *Lent*, and Beate laid on a month of "Watch and Pray" – focusing on the lead-up to Easter, with experts from "The Passion of Christ". *Easter* itself saw us back at St Peter's church with an array of activities for people in our Brockley community an Art Exhibition Café, art workshop, treasure hunt and wailing wall. The "Contemplative walk around Brockley cemetery" based on the Stations of the Cross, was especially striking. One local man turned up at our Sunday morning service recently because he had followed the walk and had been prompted as a result to re-examine his dormant faith!

Baptising Sarah Horne and Ben Swan was definitely a highlight in May, at Brockley Baptist Church. It was very moving to see a large group of teenagers grouped around Ben as they laid hands on him and prayed. Equally emotional was our farewell to Victoria Kajang, as she moved back to her home Nigeria, after some 25 years or so living in London. She had been a real backbone in the church, especially through her prayer life and support of many people – including me!

The summer brought "Inspire" and "Make Brockley Happy", when some of us went out on to the streets and park, to do some silly and not-so-silly things with people in the community. This included going on a "Treasure Hunt", which involved asking God for clues to the needs of people we then went out to meet on the streets. One very significant result was an encounter with a man who was looking for God, and asked us when we met him, "Do you have a church near here? Can I come along?" We've been in contact with him ever since Soul Survivor made its customary impact on both youth and adults, and a growing number of BCC members are now making their way to the New Wine camp in Somerset.

I visited our home groups during the summer, to get a sense of where people thought we'd got to as a church, by looking back on the past years, and asking what our pathway had been, and then to ask where we might be going in the years to come. It was an inspiring and challenging time for me – I produced a summary report on people's comments, which is available to all.

For most of the year, our Sunday morning programme led us into *encountering Jesus in the Gospels*. Indeed, the first part of this series was called "*Encountering Jesus*", as we followed people whose contact with Jesus turned their lives upside down. This led on to "*Living with Jesus*" – what was life like with the person whose enemies called "a glutton and drunkard"?! Finally, in the autumn, we focused on "*Going with Jesus*", feeling challenged by Jesus' life and teaching.

We were shocked and saddened by *Andy Wood's* death in October. But I must say that I have never been to a funeral like it! Many of Andy's ex-taxi driving mates were there, and it was amazing to see the impact on them of the family's faith in God in such a traumatic situation I came away impressed with all who took part, and with the way God can break into people's lives in the midst of tragedy.

Nick Carmichael joined us in September as our "youth work student" – starting Oasis College's three-year degree course, with us as his church placement. He very quickly adapted to a very new situation, and became part of our church family with impressive speed! In October, he and Pete le Bas took some of the youth to Arras, France, where the Mears family got them doing some unusual and fun things. Nick has been a great addition to both church and youth team – especially as Tim went off to Mexico at precisely the time Nick arrived. Tim, Ruth and Zeke spent 6 months there, as part of a Discipleship Training School run by Youth With A Mission (YWAM). They arrived back recently as thoroughly changed people! The whole church got involved in the months leading up to their departure, giving financial, prayer and relational support to them – I was proud of us all!

The year ended with our (now traditional) *Christmas Eve Service* at St Peter's church. I'm always amazed by the number of local (and not-so-local) people who come along It's always an enjoyable and inspiring time, as people packed the church on a very cold December evening.

What else happened?

• Our intern (Anna) worked hard in developing initiatives and links in the community, including Healthy Brockley activities, a new Brockley Time Bank, *Inspire* and *Make Brockley Happy*, and several in-church activities. We nearly had a second year of the internship, but the person we'd expected to join us in September changed her mind at the last moment!

- Prayer: we tried a number of different approaches through the year, including half-nights of prayer, "prayer & fasting" and "prayer & feasting" on Friday evenings, "30 minutes on Thursdays" (3 times on a Thursday), "Prayer & donuts" on Sunday mornings (intergenerational prayer led by Jane and family something I try never to miss! If you wonder why, just come along at 10am!), and several prayer couples and triplets.
- Homegroup leaders' meals: Jo T came up with the idea to invite our stalwart HG leaders to a bimonthly Monday evening meal a time to eat and be merry, as well as to honour those who give pastorally to others in the church. We were inspired by the example of Jesus in the Gospels, as he spent time feasting with his friends and others The evenings have become a tradition very quickly!
- Healthy Brockley: we produced a newsletter early in the year, and the HB team was much in evidence in organizing the Easter events. Andy T stepped back later in the year, and consequently there's been something of a hiatus in our events and activities since then But the "Come Rain Come Shine" walks continued through the year, as did some of the courses that I run for example, The Money Secret, parenting, and the How of Happiness wellbeing course.
- Missions: we sent out a number of key people from the church, across the world. Alison Gill, Victoria and Tım and Ruth, to Burundi, Nigeria and Mexico respectively. We are privileged to count such people amongst our number, and I believe God is as delighted as we are to see them 'go into all the world and make disciples"! iNet continues to do a good (though often little noticed) job at supporting and resourcing the many missionaries across the world, connected to the twelve "iNet churches". The iNet festival and conference is always a high point for many.
- Brockley churches fraternal: this grouping of local churches is steadily growing. Today it comprises over ten churches The leaders get together every 6 weeks and give valuable support to each other; the churches too hold joint services and activities during the year.
- People: it's been a tough year for Spencer family, with Lauren having major back surgery (which has been a success) and other family pressures. Esme was very ill following surgery, but made a dramatic recovery! Phil Sewell turned 60 during the year!
- **Hospitality:** one of the sources of satisfaction for me is to see the way that BCC people open their homes to others, both on a Sunday and at other times
- Goldsmiths College Christian Union: I have been involved with the Goldsmiths CU over the past few years, and took their weekend away twice in 2009! Joe Letts has also got involved during the year.
 - BCC website: in April we launched our new look website do take a look.

A lot has happened over those twelve months. God has proved himself faithful again, and we look forward to more of his life and faithfulness throughout 2010

FOR THE YEAR ENDED 31ST DECEMBER 2009

1 ACCOUNTING POLICIES

The financial statements have been prepared under the historical cost convention and in accordance with the Companies Act 2006 and follow the recommendations in Accounting and Reporting by Charities Statement of Recommended Practice (SORP) 2005

a) Incoming resources

Gifts, grants and sales are accounted for on a received basis. Tax recoverable from the Inland Revenue under the Gift Aid scheme is recognised on an accruals basis when receivable.

b) Capitalisation and Depreciation

Items of equipment are only capitalised where purchase price exceeds £1,000 As the charity has no fixed assets there is no policy on depreciation

c) Expenditure

Expenditure is accounted for on an accruals basis, inclusive of VAT, which cannot be recovered

d) Charitable Activities

This comprises all expenditure directly related to the objects of the charitable company

e) Pensions

The charitable company offers its employees a pension with Legal & General Assurance Society, administered by Kinsgworld Walder Ltd. The scheme is a defined contributions scheme. The charitable company matches employees' contribution up to 5% of their gross salary. Expenditure is charged to the Statement of Financial Activities in the period to which it relates.

f) Funds accounting

Funds held by the charitable company are

Unrestricted general funds - these are funds which can be used in accordance with the charitable objects at the discretion of the trustees

Restricted funds - these are funds which can only be used for particular purposes within the objects of the charitable company. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes. The nature and purpose of each fund is explained further in the notes to the financial statements.
