




#### Statement of Directors Responsibilities

Principle Activity of this objective was the continuing of the Not for profit company, members associations called Reading Pride incorporated at Companies House on 11-feb-2004 and it's main objective of hold a Pride Park festival, on 2<sup>nd</sup> Sept 2006 at Kings Meadow Park, Reading, and to progress the formation of Reading Pride into a Charity organisation.


