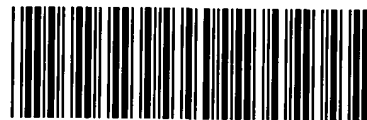

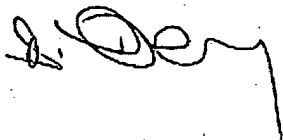
HMRC
