
- select suitable accounting policies and then apply them consistently,

S R Daniels, Director of the company is also an employee of Alpha Real Property Investment Advisers LLP (Alpha). Alpha also administers the operating partnerships in which the company had an interest during the year. For this service Alpha receives fees as stated below:
