 - (d) that the costs of complying with a request of a creditor or member for an account of the Applicant's administration of the liquidation should be an expense of the relevant Members' Voluntary Liquidations, and
 - (e) the fact that the Applicant will be entitled to apply to the Secretary of State for her release 42 days after the notice has been advertised
- Any creditor or member of the relevant company or the LLP may apply, within 28 days after the notice has been advertised, to vary or discharge this Order
- Any individual member or creditor of the relevant company or the LLP may apply within 28 days after the notice has been advertised for an order that an account be given of the Applicant's administration of the liquidation
- The costs of complying with a request of a member or creditor for an account of the Applicant's administration of the liquidation shall be an expense of the relevant Members' Voluntary Liquidations
