1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The company is reliant upon the continuing support of its director through the outstanding director's loan advanced to the company. The director has indicated that she does not intend to call upon this loan until the company's trading position has improved. Therefore the accounts are prepared on a going concern basis.

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

Turnover

Turnover represents net invoiced sales of services excluding value added tax.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Plant and machinery etc - 33% on cost and 25% on cost

Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.
