1 Accounting policies

1.1 Accounting convention

The financial statements are prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

The financial statements are prepared on a going concern basis. This may not be appropriate because the company's liabilities exceeds its assets by £11,945 at 31 May 2011.
