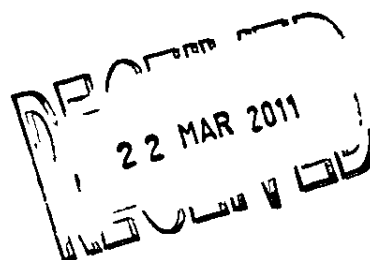

unaudited financial statements of Ahead Of The Class Productions Limited**


