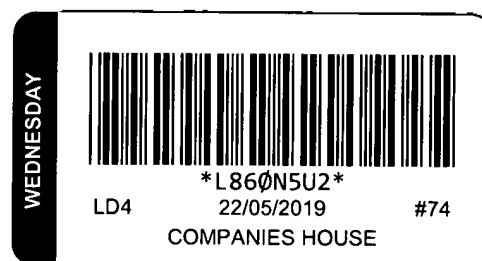





1. Accounting policies

Statement of compliance

Westcom Dedicated Private Lines Limited is a limited company incorporated in England. The registered office is Tower House, 67-73 Worship Street, London EC2A 2DZ.

The company's financial statements have been prepared in compliance with FRS 102 as it applies to the financial statements of the company for the year ending 30 September 2018.

Basis of preparation

The financial statements of Westcom Dedicated Private Lines Limited were authorized for issue by the board of directors on 21 May 2019.

The financial statements have been prepared in accordance with applicable United Kingdom accounting standards.

The financial statements are prepared in sterling which is the functional currency of the company and in whole pounds.

Profit and loss account

The company has been dormant throughout the year and has made neither a profit nor a loss. No profit and loss account has therefore been prepared.

2. Directors' emoluments

Damian Hart and Linda Pennington-Benton are employees of IPC Network Services Limited and IPC Information Systems Singapore Pte respectively at 30 September 2018 and their remuneration is borne by those entities.
