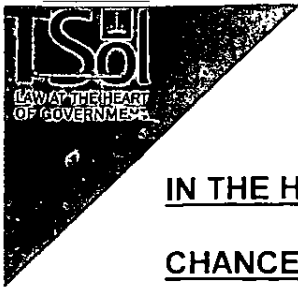

THIS COURT DOTH ORDER that the name of the above named Manorton Ltd


be restored to the Register of Companies


