ENQUIRES AND INVESTIGATIONS

I have carried out an initial review of the Company's affairs in the period prior to appointment. This included seeking information and explanations from the director by means of questionnaires and interviews; making enquiries of the Company's accountants; reviewing information received from creditors; and collecting and examining the Company's bank statements, accounts and other records.

The information gleaned from this process enabled me to meet my statutory duty to submit a confidential report on the conduct of the directors (past and present) to the Insolvency Service.

This work was also carried out with the objective of making an initial assessment of whether there were any matters that may lead to any recoveries for the benefit of creditors. This would typically include any potential claims which may be brought against parties either connected to or who have past dealings with the Company.

This initial assessment has been completed and I did not identify any further assets or actions which might lead to a recovery for creditors.

REALISATION OF ASSETS

Cash at Bank

The Company's bank account with Barclays Bank Plc was listed as being in credit to the sum of £5,631 according to the statement of affairs. In actual fact the account contained the sum of £4,998, and was subsequently credited with a further £383.47 in respect of the VAT refund due to the company. After application of the bank's final charges, the sum of £5,376 was realised upon closure of the company's account.

VAT Refund Due

The statement of affairs listed a VAT refund due of £383. The sum of £383.47 was paid directly in to the company's bank account by HM Revenue & Customs, and is reflected in the cash at bank figure detailed in the receipts and payments account.

CREDITORS

Secured creditors

The Company has no secured creditors.

Preferential creditors

The company has no preferential creditors.

Unsecured creditors

The directors' statement of affairs detailed one unsecured non-preferential creditor for £242. However two claims have been received amounting to £2,501, with the difference relating to a claim from HM Revenue & Customs. Creditor claims have not been formally agreed as there is no prospect of a dividend to unsecured creditors.

Dividend prospects

There is no prospect of a dividend to any class of creditor.

Prescribed Part

Where a floating charge is created after 15 September 2003 a prescribed part of the company's net property shall be made available to unsecured creditors.

The Company has not granted a floating charge to any creditor after 15 September 2003 and consequently there will be no prescribed part in this Liquidation.

FEES AND EXPENSES

Pre-Appointment Costs

You will recall that the statement of affairs fee of £4,000 was agreed at the initial meeting of creditors, and has been paid to G I A Insolvency Limited.

The Liquidator's fees

The basis of the Liquidator's fees has not yet been fixed.

However on 21 December 2016 a fee estimate was circulated to creditors and a resolution proposed which sought to approve the Liquidator's remuneration on a time cost basis. No votes were submitted by creditors and therefore no resolution has been passed.

The Liquidtor's proposals in relation to the setting of the basis of remuneration will be issued under separate cover.

Disbursements

The disbursements that have been incurred and paid during the period are detailed below.

Statement of Insolvency Practice 9 ('SIP9'), requires that the office holder provide a statement of the office-holder's policy in relation to recharges of disbursements. SIP9 defines disbursements as either Category 1 or Category 2 disbursements.

Category 1 disbursements comprise specific expenditure directly referable to the case and a payment to an independent third party. These may include, for example, advertising, room hire, storage, postage, travel expenses, and equivalent costs reimbursed to the office holder or his or her staff.

Category 1 disbursements are recoverable without approval, and it is the policy of G I A Insolvency to recover Category 1 disbursements when they are incurred and when funds permit.

Category 2 disbursements are costs which are directly referable to the case but not a payment to an independent third party. They may include shared or allocated costs that can be allocated to the appointment on a proper and reasonable basis, for example, business mileage.

Category 2 disbursements may be drawn if they have been approved in the same manner as an office holder's remuneration. It is the policy of G I A Insolvency to recover Category 2 disbursements once approval to do so has been obtained and when funds permit.

The only Category 2 disbursement recovered by G I A Insolvency is business mileage, which is charged to the case at 45 pence per mile. A total of 67 miles have been travelled in relation to the case, incurring disbursement costs of £30.15. An unsecured creditor may, with the permission of the court or with the concurrence of 10% in value of the creditors (including the creditor in question), apply to court to challenge the amount and/or basis of the Liquidator's fees and the amount of any proposed expenses or expenses already incurred, within 8 weeks of receipt of this report. Any secured creditor may make a similar application to court within the same time limit.

EC REGULATIONS (WHETHER PROCEEDINGS ARE MAIN PROCEEDINGS OR TERRITORIAL)

The Company's centre of main interest was in England and therefore it is considered that the EC Regulations will apply. These proceedings are main proceedings as defined in Article 3 of the EC Regulation.

CONCLUSION

Once the basis of the Liquidator's remuneration has been approved and drawn, the liquidation will be closed.
